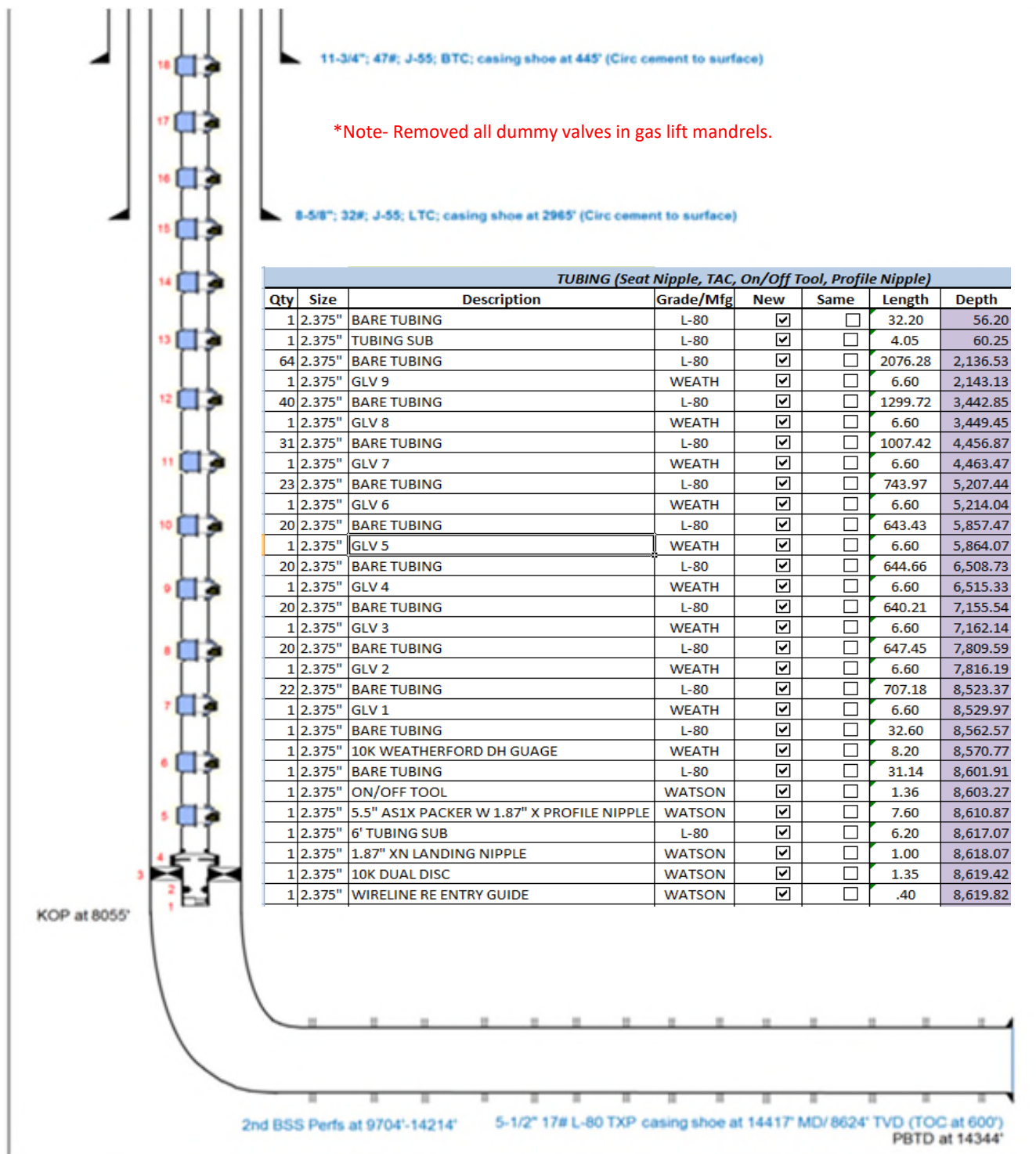

MU 1.90" GAUGE RING AND RIH TO 8563'. LOCATE FLUID LEVEL IN TBG @ 7200'. MAKE COLD CALL FOR PFA TO SHOOT FLUID LEVEL IN CASING. LOCATED FLUID LEVEL @ 1200'. NOTIFIED PE OF FLUID LEVEL DIFFERENCES AND DECISION WAS MADE TO SET BLANKING PLUG AND LOAD TBG BEFORE PULLING GLV'S. SECURED WELL AND SHUT DOWN FOR THE DAY.

7/10/2019 ROAD CREW TO LOCATION. HTGSM AND HAZARD HUNT. RIG UP HOT OILER AND FLUSH TBG WITH 40 BBLS FRESH WATER. MU 1.87" PX BLANKING PLUG AND RIH. SET BLANKING PLUG IN PROFILE NIPPLE @ 8603'. MU PRONG, RIH AND INSTALL PRONG IN BLANKING PLUG. LOADED TBG WITH 21 BBLS. EQUALIZE TBG/CSG PRESSURE. RIH WITH OK-1 KICKOVER TOOL AND JDC PULLING TOOL. PULLED DUMMY VALVE FROM MANDREL @ 8523'. MU PRONG PULLING TOOL, RIH AND PULL PRONG FROM BLANKING PLUG TO ALLOW WELL TO EQUALIZE WHILE PULLING REMAINING DUMMY VALVES. MU OK-1 KICKOVER TOOL AND JDC PULLING TOOL.
