Perf 3602-3604', 3615-3618', 3633-3635', 3647-3649', 3734-3737', 3752-3756', 3767-3771', 3787-3788', 3820-3822', 3826-3829', 3833-3835', 3856-3861' (2 SPF). Use RBP & pkr to isolate perf intervals for stimulation. Acidize 3720-3880' w/ 2500 gals 15% NEFE HCL acid, 600# rock salt & flush w/ 250 bbls 2% KCL wtr. Acidize 3590-3656' w/ 1500 gals 15% NEFE HCL acid, 400# rock salt & flush w/ 150 bbls 2% KCL wtr. Release pkr. POOH w/ pkr & RBP. TIH w/ production string: ~106 jts 2-3/8" J-55 tbg, 6 jts 2-3/8" J-55 coated tbg, SN, 4' perf sub, mud jt w/ bull plug. RIH w/ pump & rods. RDMO. RTP.
