Pump 20 bbls gel water and 40 bbls gel spacer, followed by 450 sks of 14.8 ppg lead cmt. Drop plug and displace with 50 bbls brine. 75 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
