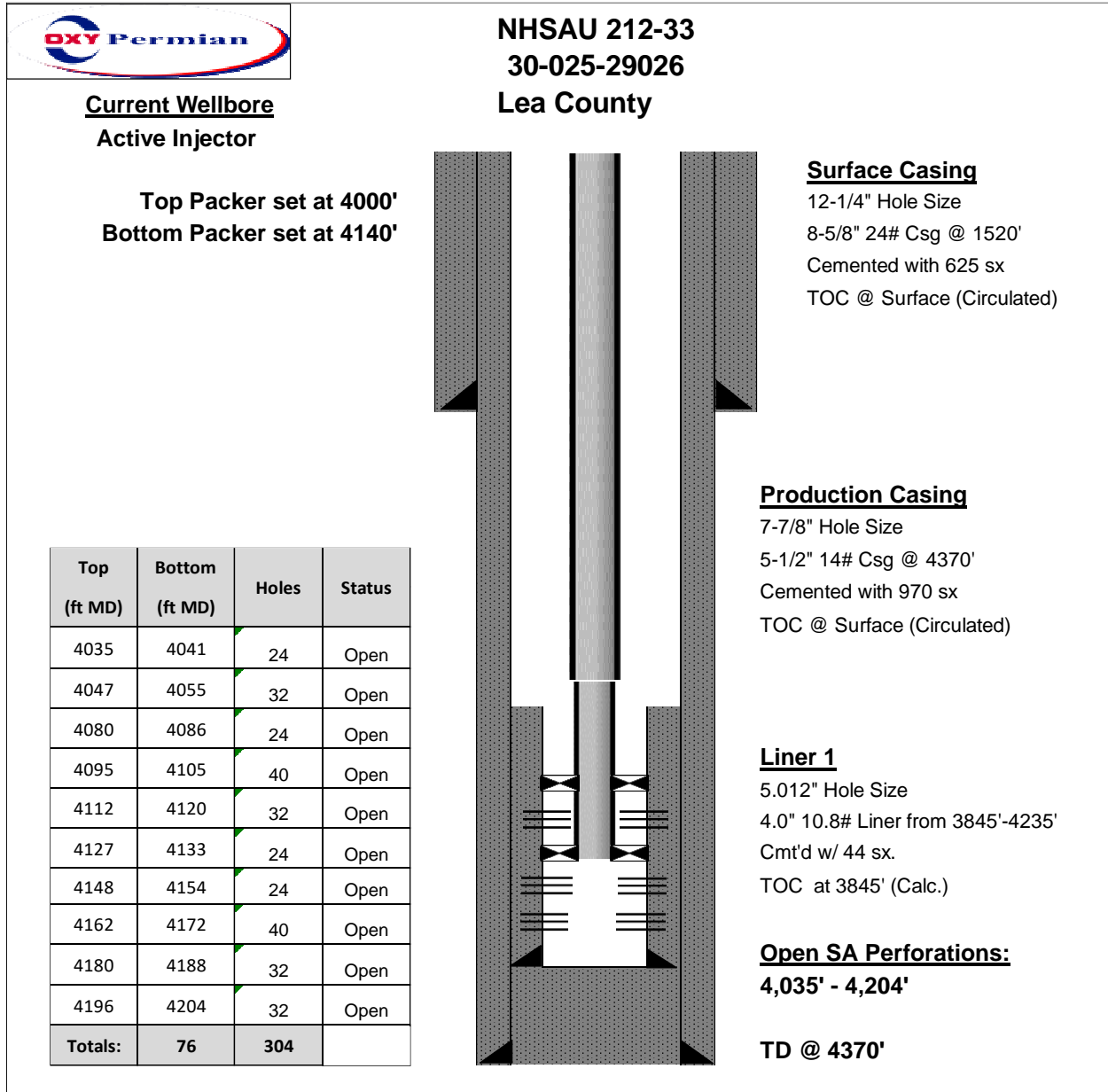

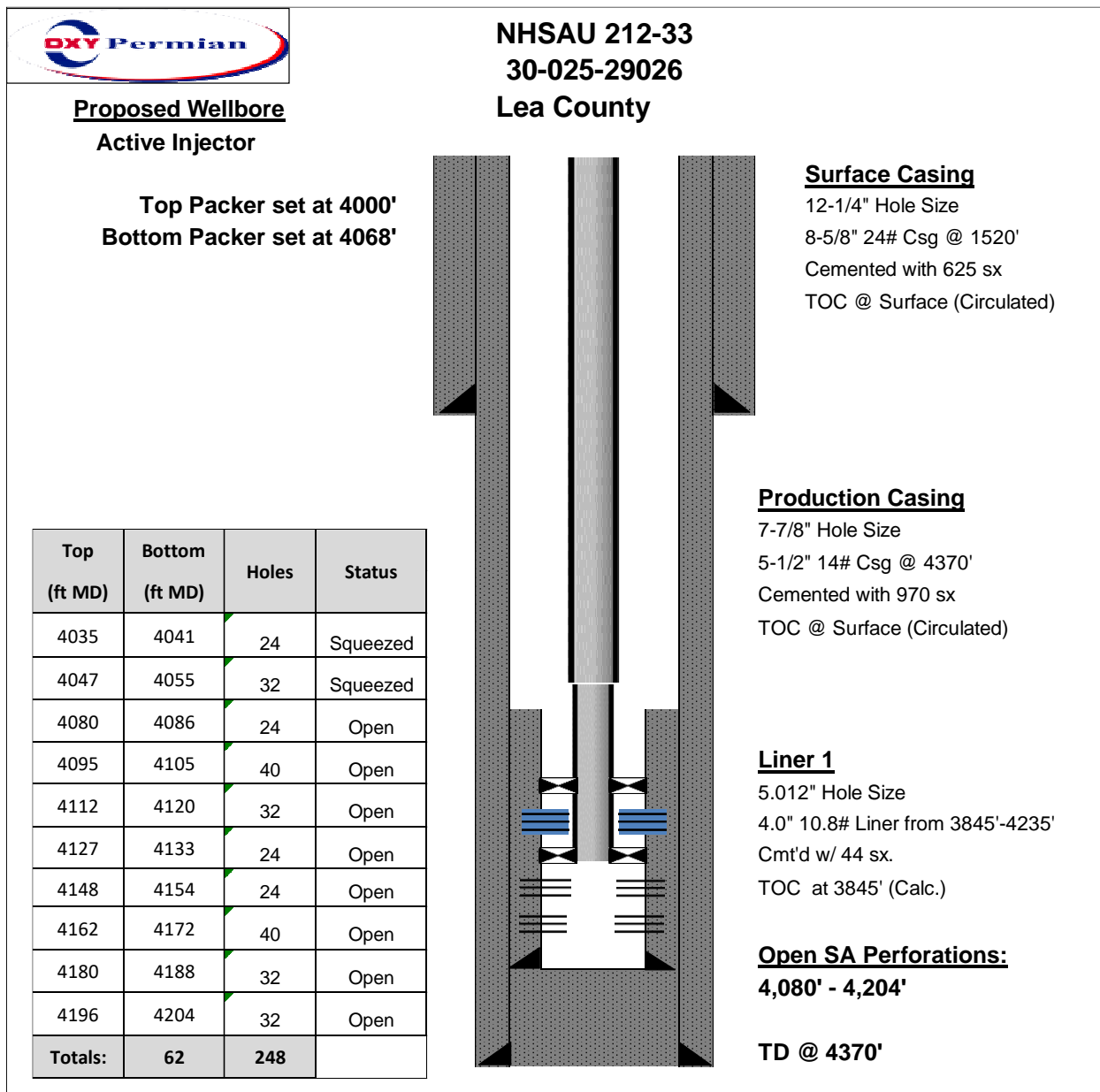
Procedure

1. POOH w/ Injection Equipment
2. RU WL x Set 4.0" CIBP @ 4068' x RD WL
3. RIH w/ CICR x Cement squeeze Z2 perforations w/ ~600 sx cmt
4. RIH w/ bit x Drill out CICR & squeeze to CIBP x Test squeeze to 1100#
5. DO CIBP
6. Run injection equipment including straddle packer assembly
 - Set top packer @ 4000'
 - Set bottom packer @ 4068'
7. RDPU
