Osage Federal #8 – Temporarily Abandon

Objective:

TA the Osage Federal #8 well that has been shut in and is currently inactive. TA well while evaluating long term plans.

Location:

- API: 30-015-26089
- Latitude, Longitude: 32.619, -104.061

Well History:

- 04/18/1989: Spud well – Drill as a Strawn and Wolfcamp producer.
- 06/14/1989: Completion – 2 stage acid frac. Put well on production.
- 04/12/1991: Convert well to Bone Springs w/ abrajizet perfs. Squeezed off Wolfcamp and Atoka w Class H cmt.

Current Configuration:

- Surface Casing: 20" 94# H-40, Surface – 340' MD. (635 sx cmt circulated)
- Intermediate Casing: 8-5/8" 32# J-55, Surface – 3,200' (1,300 sx cmt circulated)
- Production Casing: 5-1/2" 20# and 17# N-80, Surface – 11,900' (2,450 sx cmt circulated)
 - Drift = 4.653", ID = 4.778"
- Perforations
 - Strawn – 10,406' – 10,487'
 - Wolfcamp – 9,256' – 9,295'
 - Atoka: 10,816' – 10,828'
 - Bone Springs – 5,339' – 5,351' (RBP @ 5,407')

Procedure:

1. MIRU workover rig. Check tubing and casing pressure, order out kill fluid if required.
2. ND Injection tree, NU & test BOPE
3. Unknown from prior records if the well has tubing and rods in the hole. If so, unseat the pump and POOH LD all rods and tubing.
4. Order out ~5,500' of 2-3/8" work string for TA operations.
5. PU 5-1/2" 20# scraper and 4.5" bit. RIH with bit and scraper on work string to 5,407' and tag RBP. Note any restrictions felt while running.
6. POOH with bit/scraper and tubing. Stand back tubing and lay down bit/scraper.
7. PU & RIH with 5-1/2" 20# CIBP on 2-3/8" work string. Set CIBP at 5,275' MD w/ 35' of cmt on top.
8. Circulate hole over to clean packer fluid.
9. Pressure test CIBP and casing to 500 psi for 10 minutes to verify plug is holding.
 - a. Hold pressure for 30 minutes and verify less than 10% pressure drop
 - b. Open all intermediate/surface casing valves during internal pressure test and verify no flow or change in pressure.
10. POOH with tubing laying down and LD setting tool.
11. ND BOP, NU
12. Clean location and RDMO




