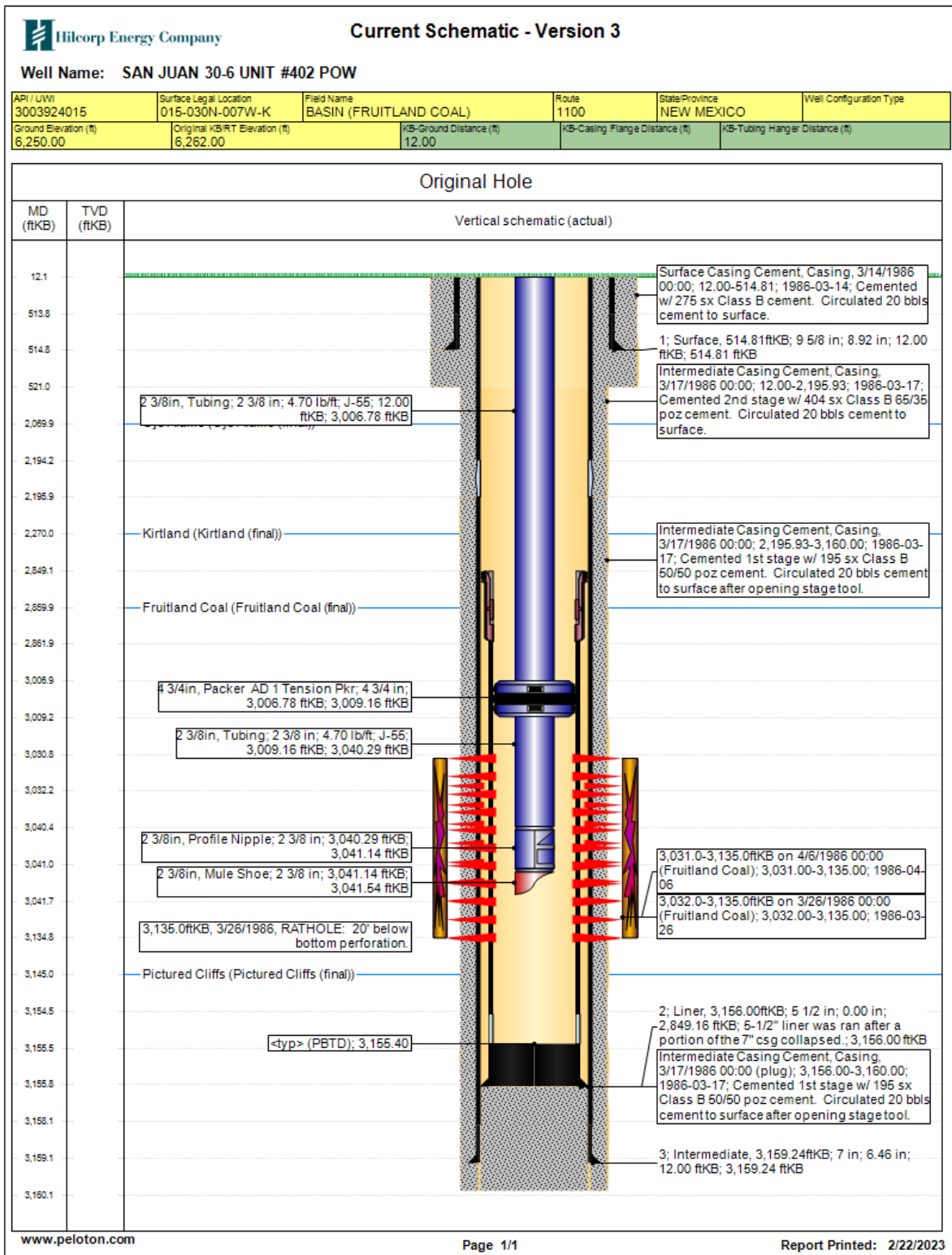

1. Perform Bradenhead test per NMOCD regulations.
2. Rig up test truck with calibrated chart.
3. Load casing to approximately 550 psig and chart well for minimum of 30 minutes to MIT casing.
  - a. Contact NMOCD to have test witnessed before charting.
4. Relieve pressure from charting and isolate all casing valves.
5. RD test truck and move out.

Refer to 43 CFR 3162.3 - 2. MIT are not referenced as a required item for Form 3160-5 approval. MITs are only required for TA approval as cited in DOI BLM IM 2020-006. But this IM does not require prior approval of MITs, only that one has to be done before TA approval.
