3/23/2023	Rig up and begin LD rods (117 3/4" and 8 1-1/2" K bars). ND Flange. NU BOP. Rig down work floor and equip. POOH 104 jts and tally. RIH w tbg open ended to tag CIBP @ 3,307'. Called BLM.
3/24/2023	Circulated 137 bbls of FW and csg started flowing. Tag plug @ 3307. POOH w 107 joints and rig up WL. RIH and set CIBP @ 2,358'. Test csg to 500 psi for 30 min w 15 bbls FW. Good test.
