Pressure tested csg, held 500 PSI. Spotted 40 sx class C cmt @ 1897-1501'. Spotted 45 sx class C cmt w/ 2% CACL @ 1220-775'. WOC. 03/02/23 Tagged plug @ 775'. ND BOP. Spotted 47 sx class C cmt @ 217' & circulated to surface. Rigged down. 03/03/23 Moved in backhoe and welder. Cut off well head & anchors. Ably w/ BLM verified cmt @ surface via picture text message. Welded on "Above Ground Dry Hole Marker". Backfilled cellar, cut off deadmen, cleaned location, and moved off.


