- 4/11/23** Made BLM and NMOCD P&A operations notifications at 9:00 AM MST.
- 4/12/23** Arrived at location. Held safety meeting. Wrote and reviewed JHA with crew. Moved rig and equipment to location. Prepared location. R/U unit and equipment. ND WH, NU BOP, RU floor. Function tested BOP. Picked up tag sub. TIH with tubing to 1752'. R/U cementing services. Established circulation with 16 bbls, pumped 28 bbls total. Pumped plug #1 from 1752' to 1420' with 34 sacks. R/D cementers. L/D 9 joints and TOO. WOC. TIH and tagged top of plug #1 at 1548'. L/D 25 joints and TOO. Secured and shut in well for the day.
- 4/13/23** Arrived at location. Held safety meeting. Wrote and reviewed JHA with crew. Attempted to pressure test casing but was unsuccessful. Casing has a hole in the top collar. R/U wireline services. RIH and logged well. Wireline unable to get passed 1128'. TIH with tubing. Tagged top of plug #1 at 1448'. R/U wireline services and logged well to 1420'. R/D wireline services. TIH with 24 joints and set EOT at 750'. R/U cementing services. Pumped plug #2 from 750' to surface. WOC 3 hours. TIH and tagged cement at 80'. Cement was still curing. Secured and shut down well for the day.
- 4/14/23** Arrived at location. Held safety meeting. Wrote and reviewed JHA with crew. TIH and tagged top of plug #2 at 94'. Rigged down floor, tongs, and slips. ND BOP. Dug around well head. Performed WH cutoff and safely removed WH. Installed P&A marker per all state and federal regulations. Topped off both casing strings and filled the cellar with 13 sx. Rigged down all equipment and prepared to MOL.

Plug #1: (Perforations, 1,752'-1,448', 34 Sacks Type III Cement)

TIH with tubing to 1752'. R/U cementing services. Established circulation with 16 bbls, pumped 28 bbls total. Pumped plug #1 from 1752' to 1420' with 34 sacks. R/D cementers. L/D 9 joints and TOO. WOC. TIH and tagged top of plug #1 at 1548'. R/U wireline services. RIH and logged well. Wireline unable to get passed 1128'. TIH with tubing. Tagged top of plug #1 at 1448'.

Plug #2: (Surface, 750' to Surface', 184 Sacks Type III Cement (13 sx for top off))

TIH with 24 joints and set EOT at 750'. R/U cementing services. Pumped plug #2 from 750' to surface. WOC 3 hours. TIH and tagged cement at 80'. Cement was still curing. TIH and tagged top of plug #2 at 94'. Performed WH cutoff and safely removed WH. Installed P&A marker per all state and federal regulations. Topped off both casing strings and filled the cellar with 13 sx.


