Ran Downhole camera and discovered 360 deg parted casing @ 2,341 and 2,525. Ran a 2. 875 40 arm caliper that revealed joint has shifted. Ran a CBL from 12,100 to Surface but TOC could not be determined.

Marathon request to perform the following to fix the parted casing:
Run a dressing BHA to dress up casing ahead of expandable casing patch.
Run a composite plug below target interval for depth correlation.
Run liner/patch via PH6 work string and land as follows:
Top: 2,258 (MD)
Bottom: 2,575 (MD)
Total Length: 317 ft.
