 - Only keep yellow band equipment
 - Lay down 200' of 3/4" rods
3. Send pump and TAC for repair
4. RIH w/ bit and bailer to TD
5. MIRU wireline
6. Add perf w/ 4 SPF as follow:
 - 3821 – 3990
7. RIH w/ sonic hammer
8. Acidize well with 7,000 gallons of 15% HCL
9. Hydrotest tbg to 80% burst
10. RIH w/ TAC, tbg and rods
 - Pick up 200' of new 1-1/2" sinker bars
11. Long stroke pump and ensure good pump action
12. RTP

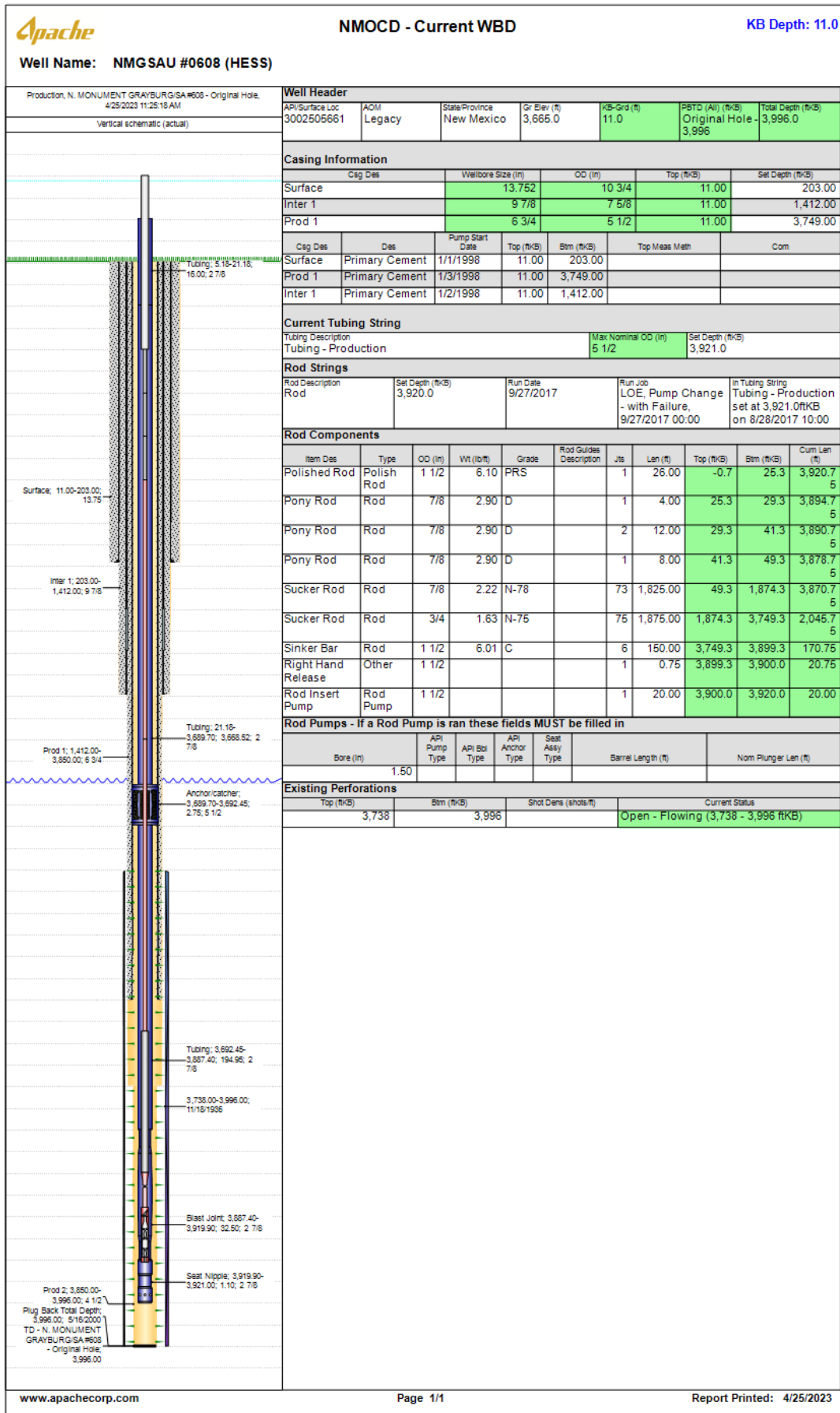
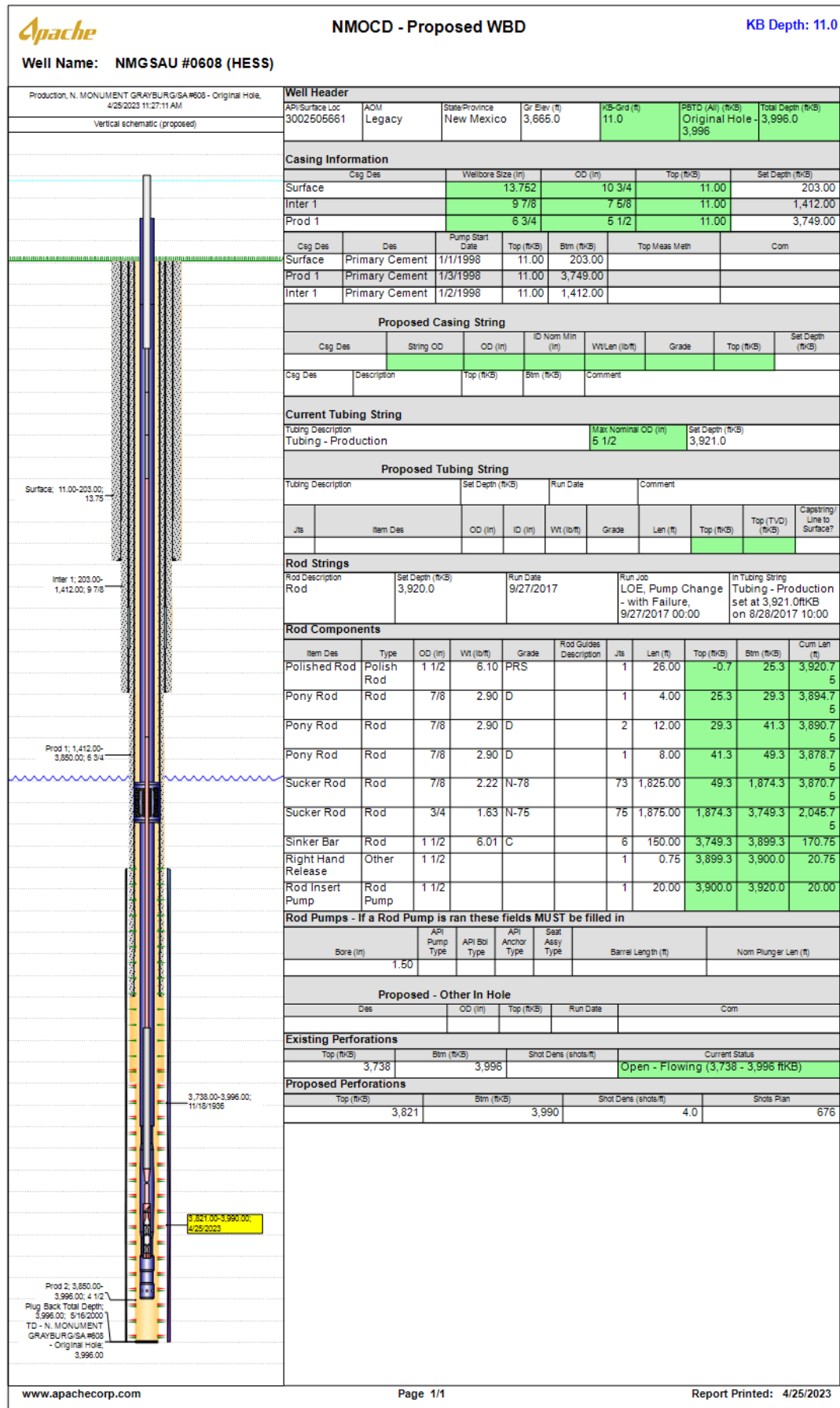
Figure 1 – Current Wellbore Diagram
