4. Spot cmt and set TOC @ 3850' (need to isolate from 3850 to TD)
5. MIRU wireline and add the following perfs w/ 4 SPF:
 - o 3780 – 3830
6. RIH w/ sonic hammer
7. Acidize well with 6,000 gallons of 15% HCL
8. POOH laying down workstring
9. Set packer @ 3,672'
10. Inform NMOCD 24 hrs. prior to performing MIT
11. Return well to injection

Figure 1 – Current Wellbore Diagram

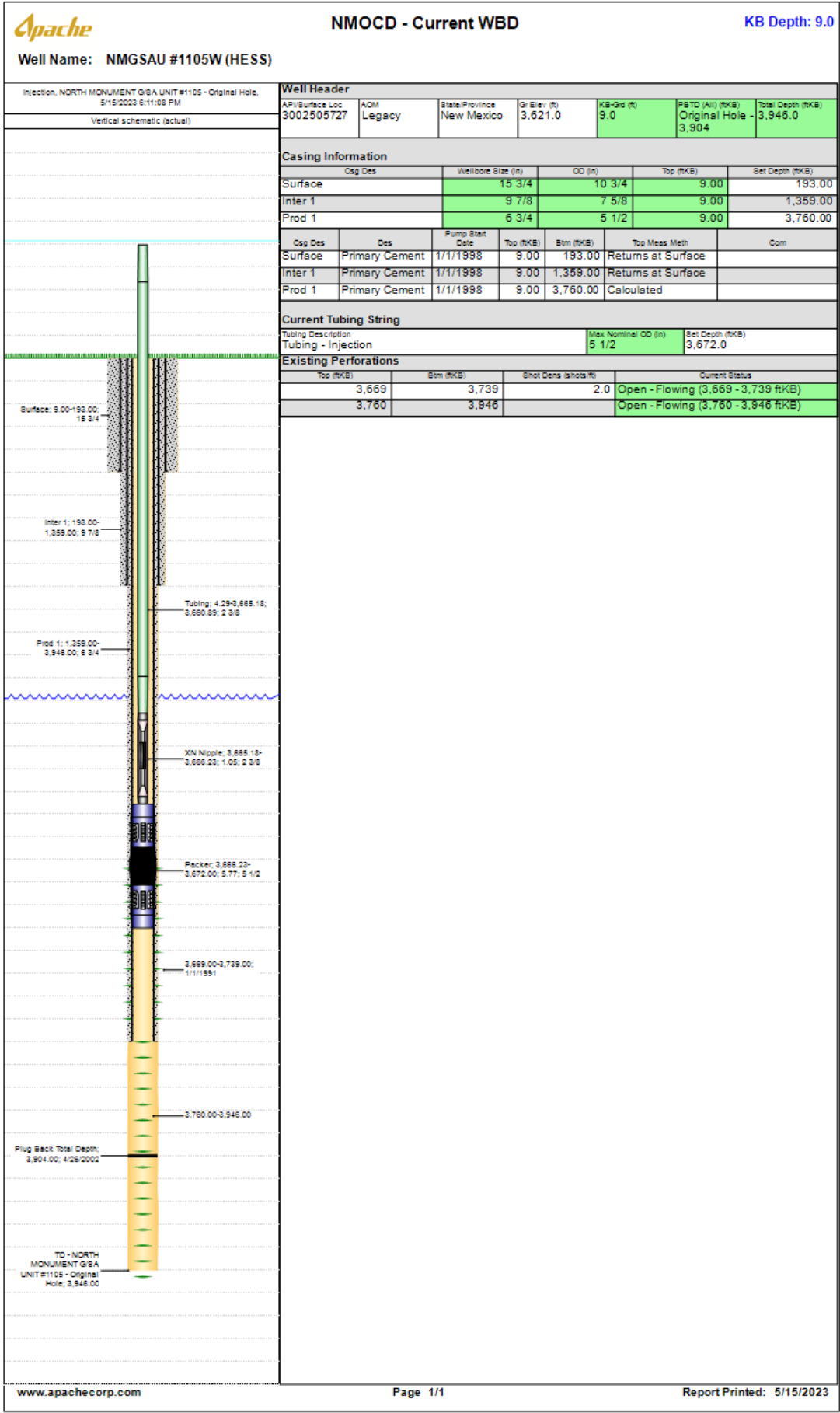
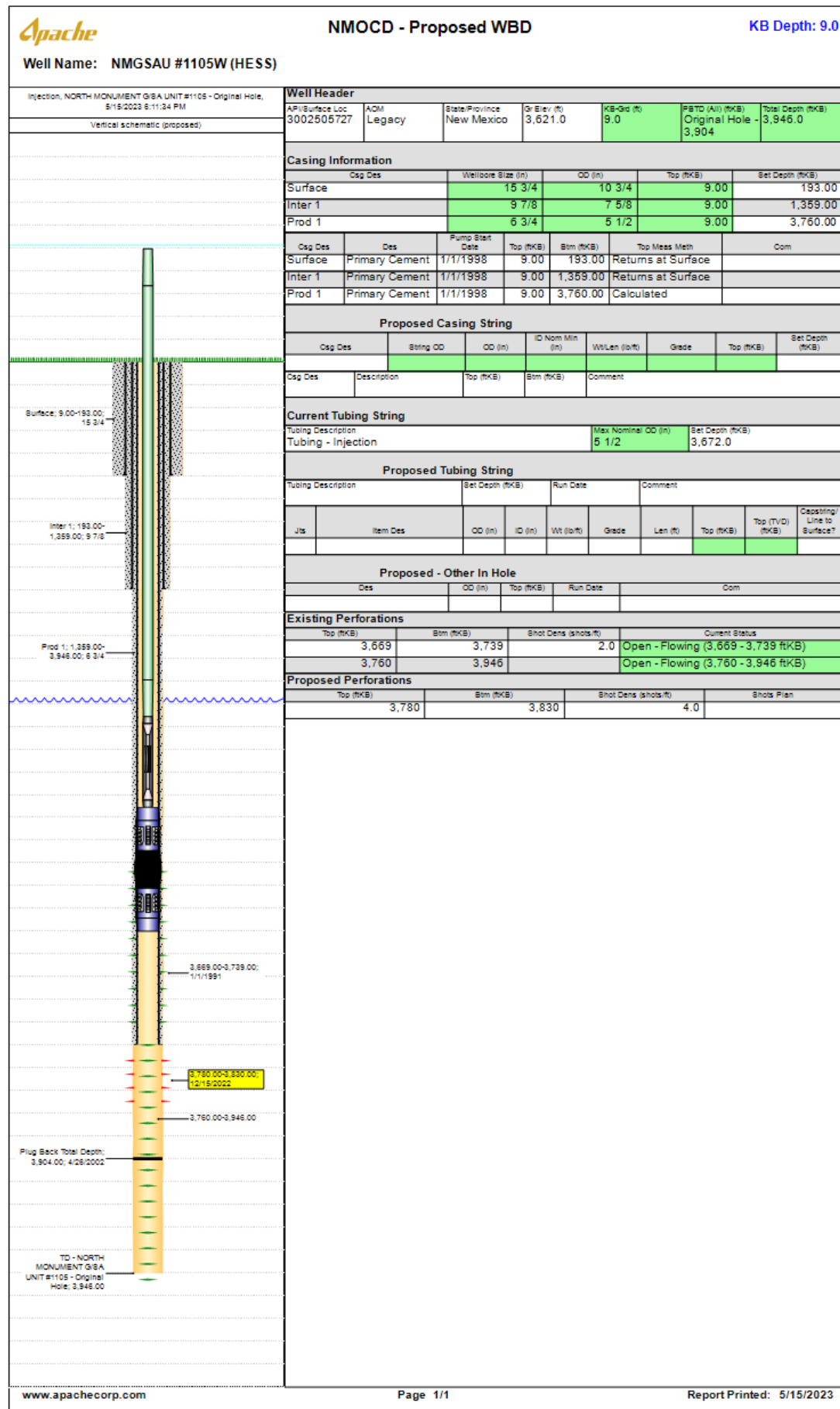


Figure 2 – Proposed Wellbore Diagram
