 - Lay down 1-1/4" pump
3. Send pump and TAC for repair
4. RIH w/ bit and bailer to TD
5. MIRU wireline and add the following perfs:
 - 4 SPF
 - 3863 – 3952
 - 6 SPF
 - 3967 – 3996
 - 3996 – 4008
6. RIH w/ sonic hammer
7. Acidize well with 4,000 gallons of 15% HCL
8. Lay down workstring
9. Hydrotest tbg to 80% burst
10. RIH w/ TAC, tbg and rods
 - Pick up 1-1/2" pump
 - Pick up 500' of 7/8" D grade rods
11. Long stroke pump and ensure good pump action
12. RTP

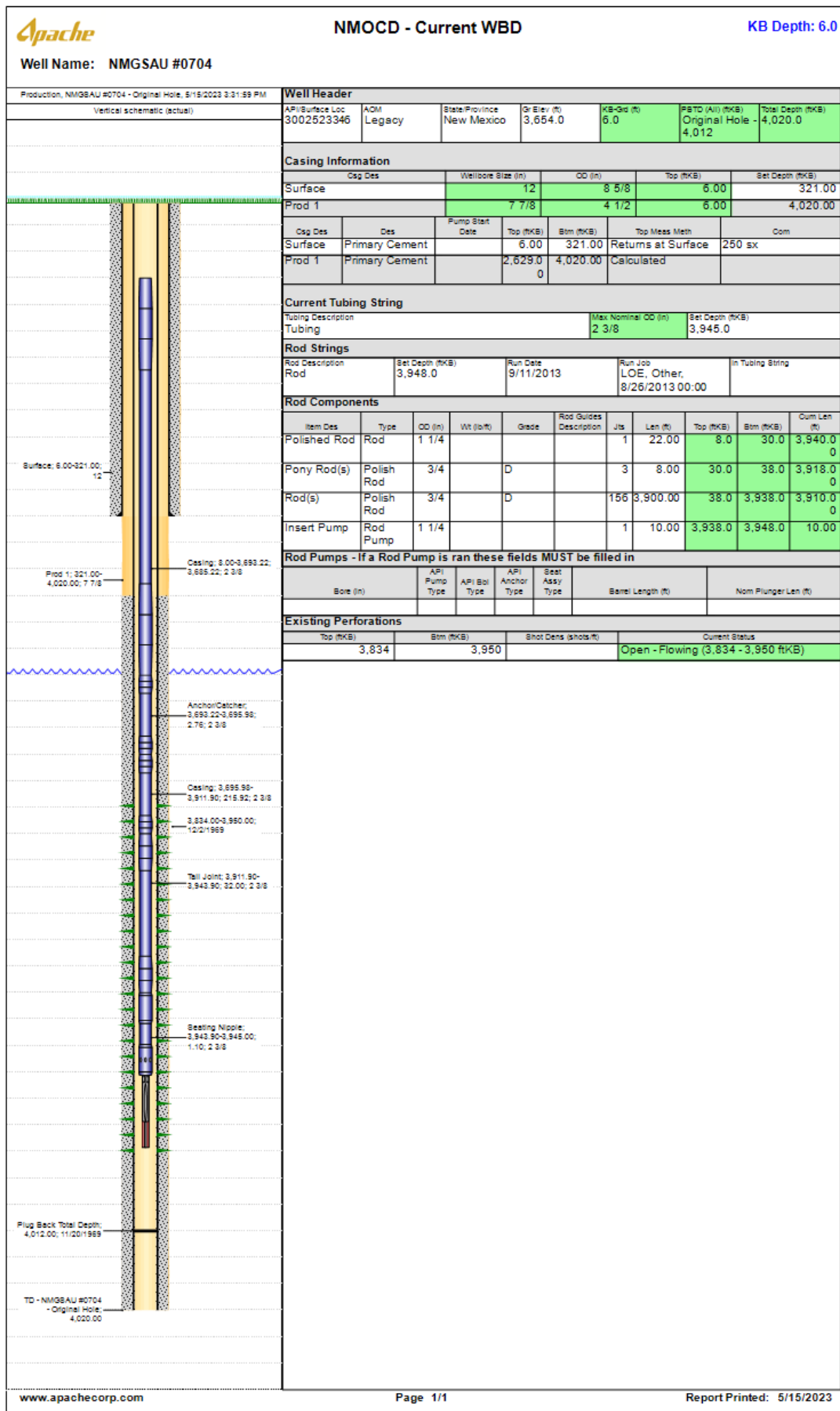
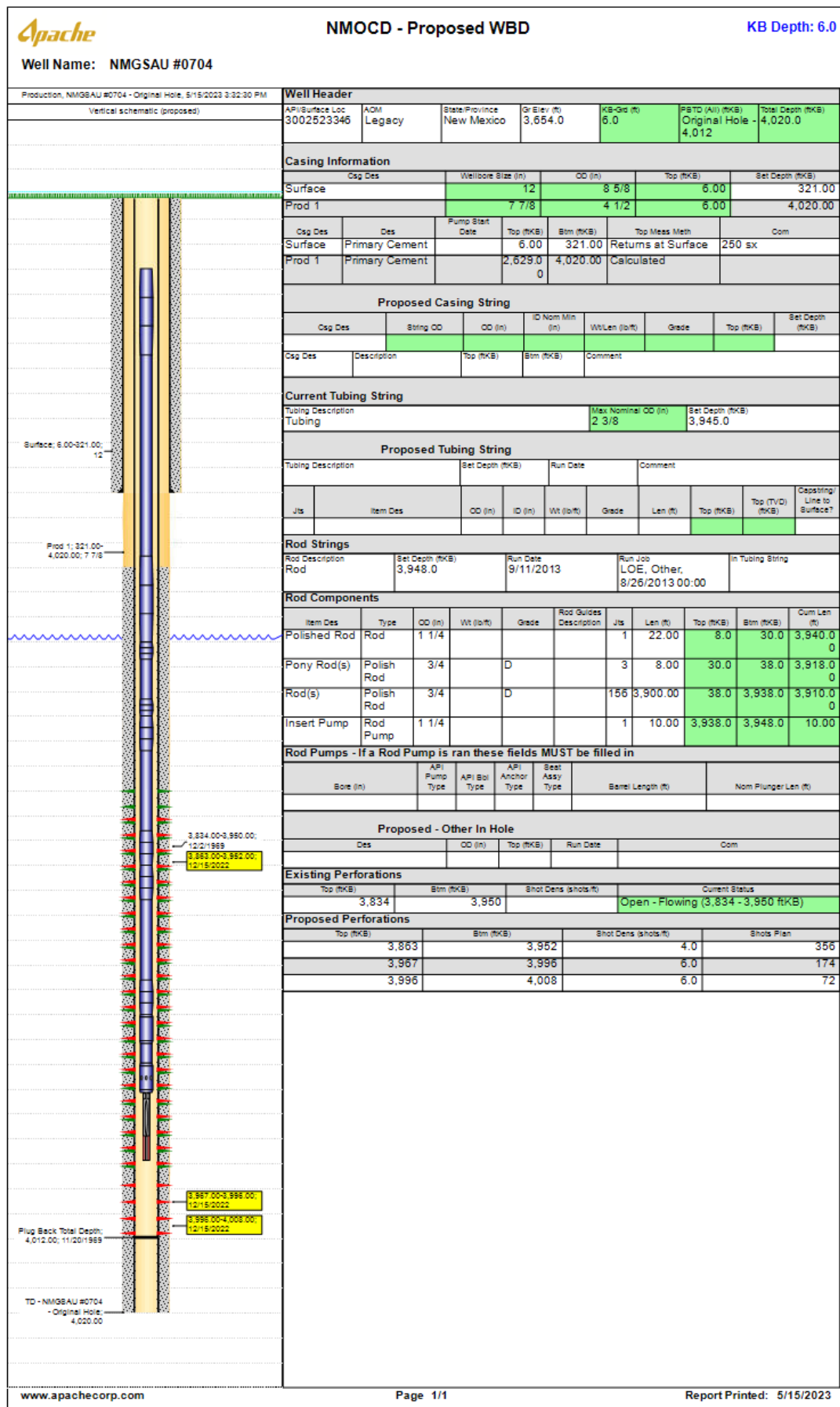
Figure 1 – Current Wellbore Diagram
