This extension is necessary in order to allow EOG, as operator, to service offset depletion and maximize recovered resources. Therefore, EOG has prioritized development in the Wolfcamp formation and delayed the development of the Bone Spring formation. Additionally, the simultaneous development and production of the two formations would exceed infrastructure capacities likely resulting in the need to flare gas and/or truck oil and water.

EOGs goal is to spud these wells by July 31, 2024.
