### P&A Reclamation Scope of Work:

- 1. No drilling pit reclamation needed.
- 2. Rip the well pad. Install berm to prevent access to reclamation along lease road (see diagram).
- 3. The total area (See Diagram), of the reclamation is 0.32 acre. Seed in early to mid-July 2021 to take advantage of monsoonal rains with below listed mix. Seeding can be broadcast or planted with a seed drill (see table below). A 500' radius trash sweep must be conducted with all trash removed.


