Lead cement 1,380 sxs, Slurry 452 bbls., 1.84 cu. ft.; 35% B_Poz+65% CLC; Tail 350 sxs, Slurry 79.2 bbls., 1.27 cu. ft., 50% B_Poz+50% Premium CLC; full returns, 131 sxs circulated to surface. Pressure test csg. 1,500 psi 30 minutes – good test. Install Cameron abandonment cap.
