Drill 17.5" intermediate section from 1,201' to 1,294'. 10/11/22: Drill 17.5" intermediate section from 1,294' to 2,301'. 10/12/22: Drill 17.5" and TD intermediate section from 2,301' to 2,990'. 10/13/22: Run 13-3/8" 54.5# J-55 BTC intermediate casing to 2,984'. Lead cement 1,255 sxs, CLC, 409 bbl. slurry, 1.83 cu.ft.; Tail cement 385 sxs, CLC, 95 bbl. slurry, 1.37 cu.ft.; 307 sxs returned to surface. Tested casing to 1,500 psi for 30 minutes – good test.
