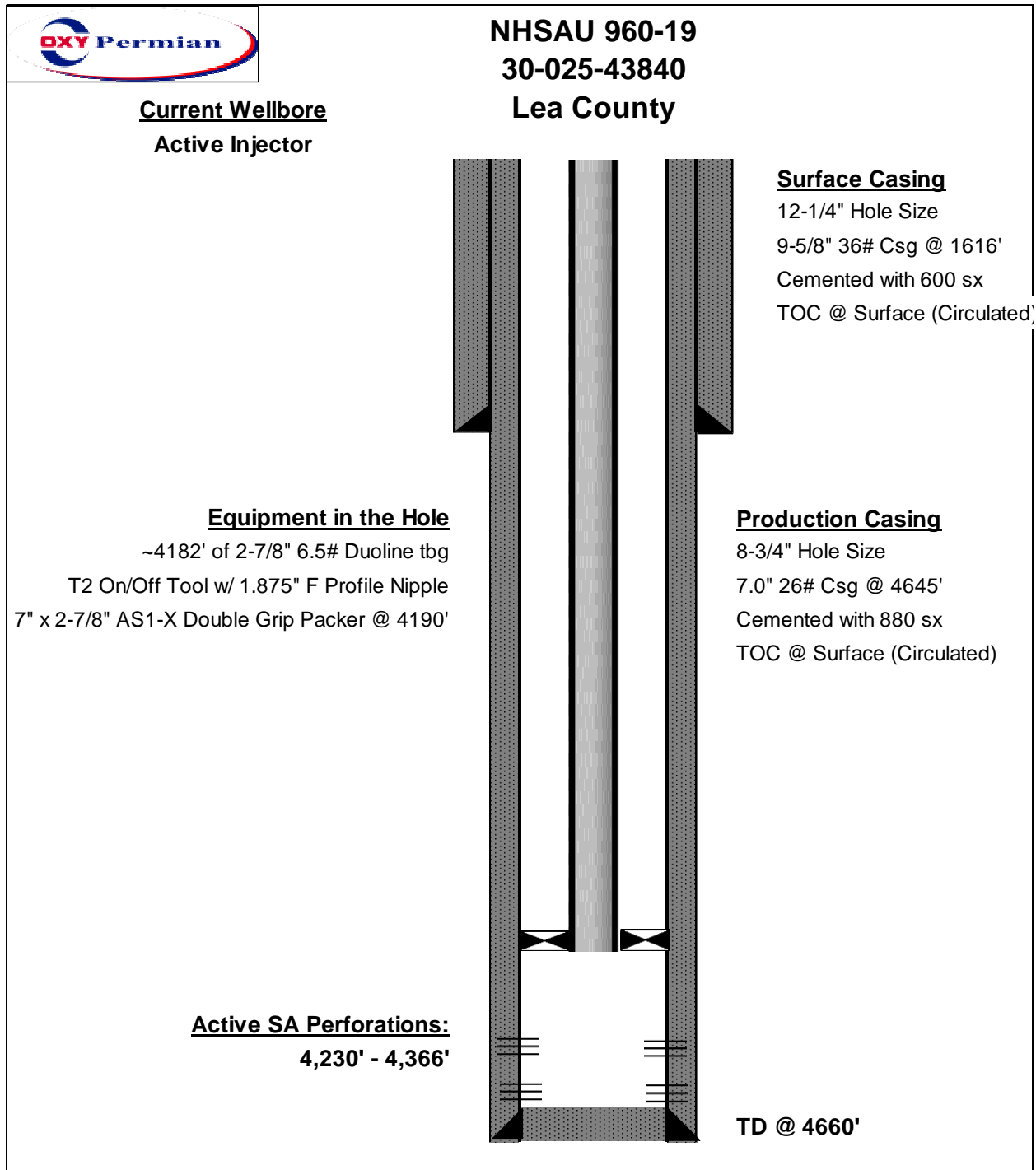

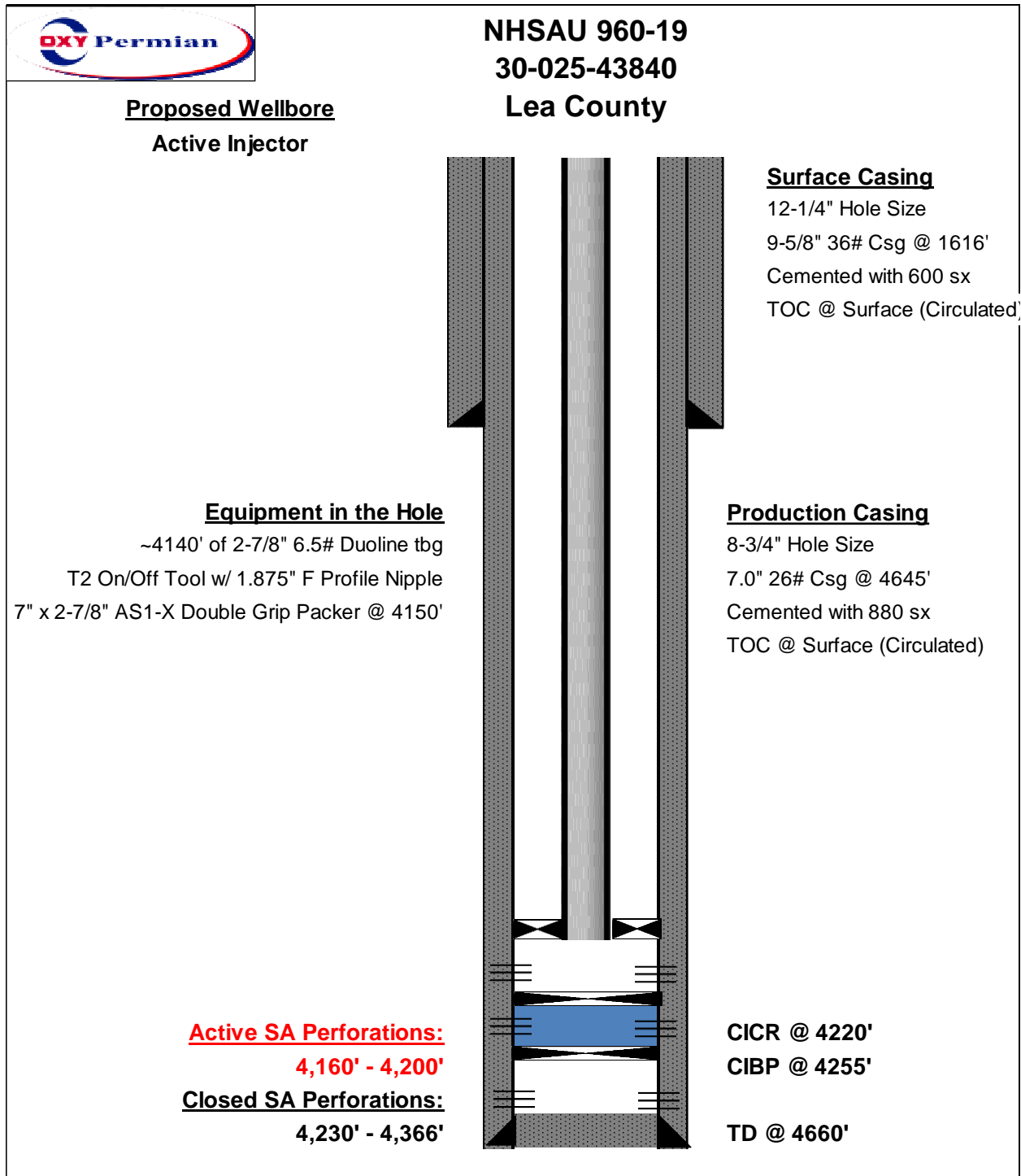
Procedure:

1. MIRU PU
2. Kill well x ND WH x NU BOP
3. POOH w/ Inj Eqpt
4. RU WL x Set CIBP @ 4255' x RD WL
5. RIH w/ CICR on 2-7/8" workstring & set @ 4220'
6. Cement squeeze perforations. Sting out retainer, reverse out excess cmt, & POOH w/ workstring
7. RU WL
8. Perforate casing from 4160'-4200'. RD WL
9. RIH w/ packer x Acidize new perforations. POOH.
10. Run injection equipment
11. RD PU
12. Return well to injection
