Procedure Description: Epic Energy, LLC requesting a change to the sampling regime prescribed in the COA's approved reclamation plan to the the new proposed sampling plan as follows: • Around the wellhead: excavate a 10 ft by ~1ft (to the level of the concrete at the base of the well marker) radius around the wellhead. If no further staining is observed, take a 5 point composite sample of the excavated surface at regular intervals around the wellhead and analyze for the full suite of contaminants described in UMU's clean-up standards. If further staining is observed, continue to excavate until all stained material is removed and follow the same sampling regime. • Tank battery: excavate the full footprint of the previous tank battery to a depth of 24 inches, then take a 10 point composite sample of the excavated surface (grab samples that make up the composite should be a representative of the entire battery's footprint) and analyze for the full suite of contaminants described in UMU's clean-up standards. If further staining is observed, continue to excavate until all stained material is removed and follow the same sampling regime. • There were a few areas identified throughout the pad that had observably stained soil. Excavate these areas until stained material is no longer observed. Epic Energy, LLC requesting a 30 day extension of final reclamation earthwork and seeding since the deadline prescribed in the approved plan is quickly approaching (11/30/2022). This is due to the new proposed sampling plan that was discussed during the on-site visit on November 7, 2022 with Scott Clow, David Retherford, Michael Dean, Stephanie Tsosie and Laura Hartman.
