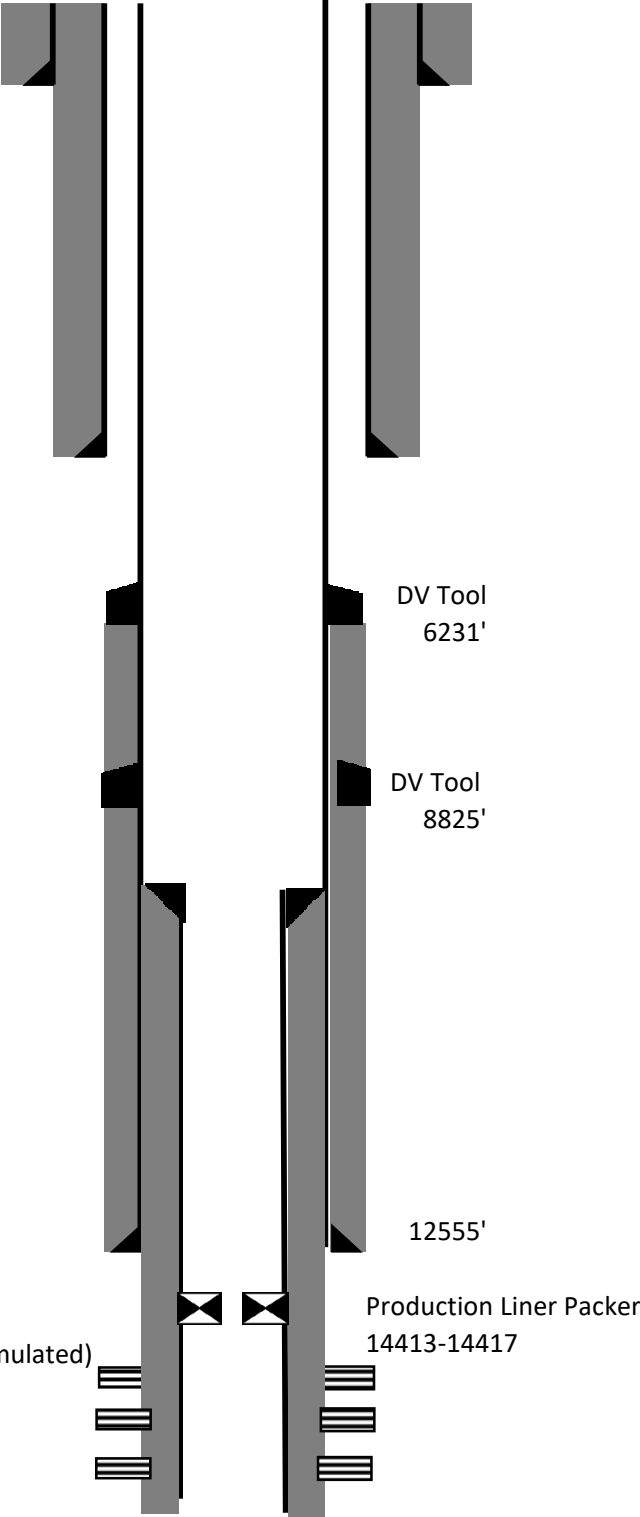

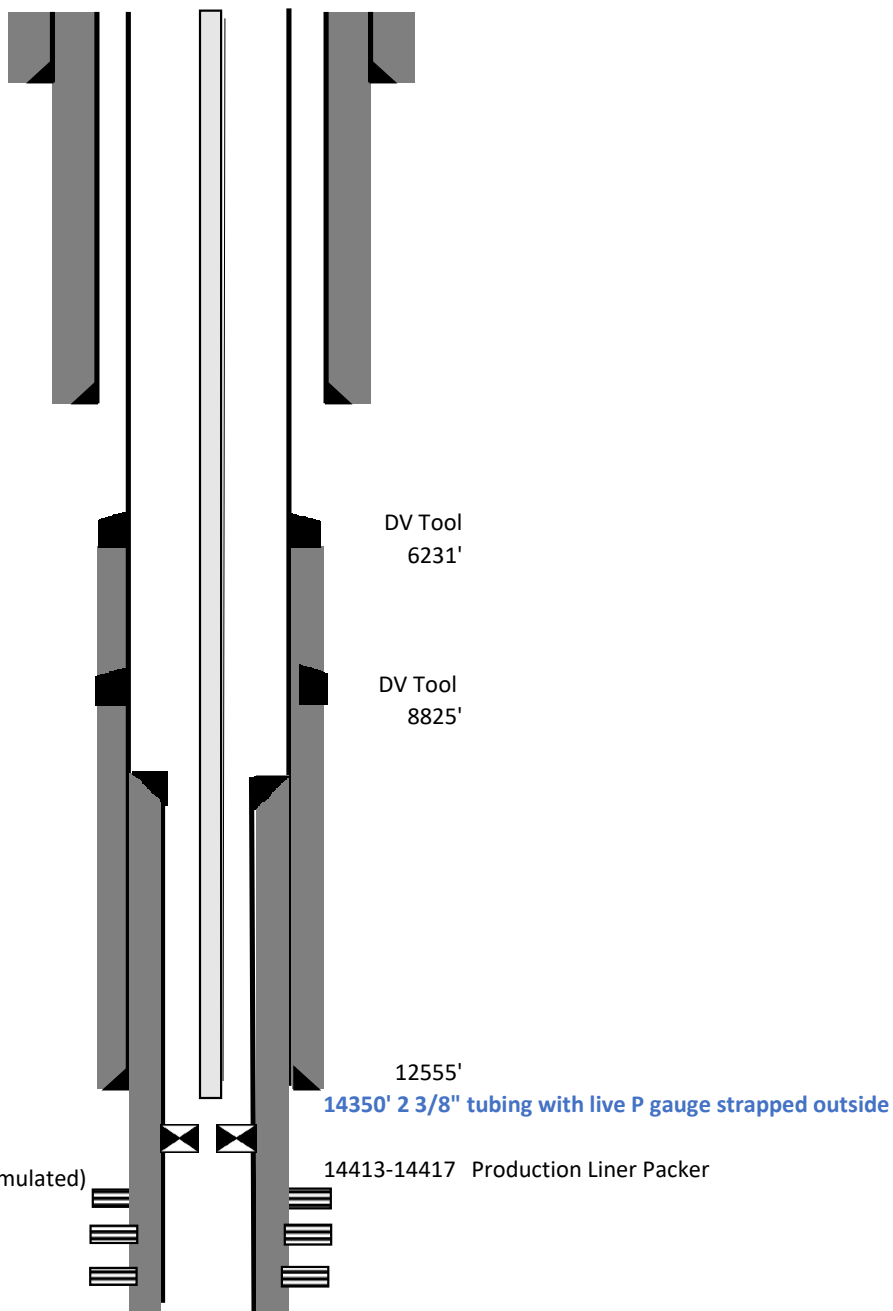

Proposed Procedure

1. Rig up and RIH with plug and packer. Set RBP above production liner packer at 14413'.
2. Pressure test casing to 500 psi for 30 minutes.
 - a. If pressure holds, continue forward with prep for pressure monitoring in step 3.
 - b. If pressure does not hold, continue forward with P&A per sundry 2707014.
3. RIH with tubing and pressure gauge with live wire banded to tubing.
