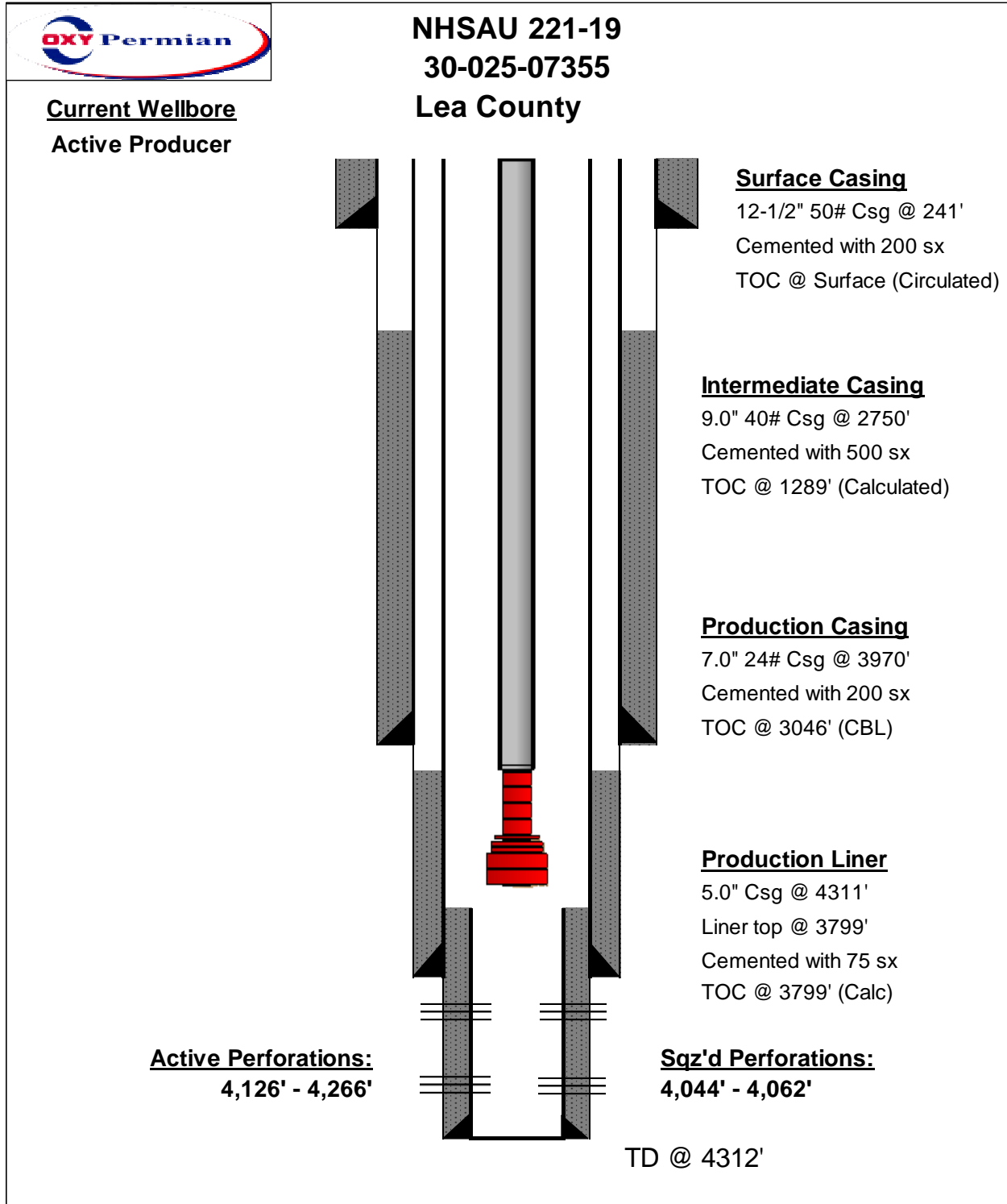

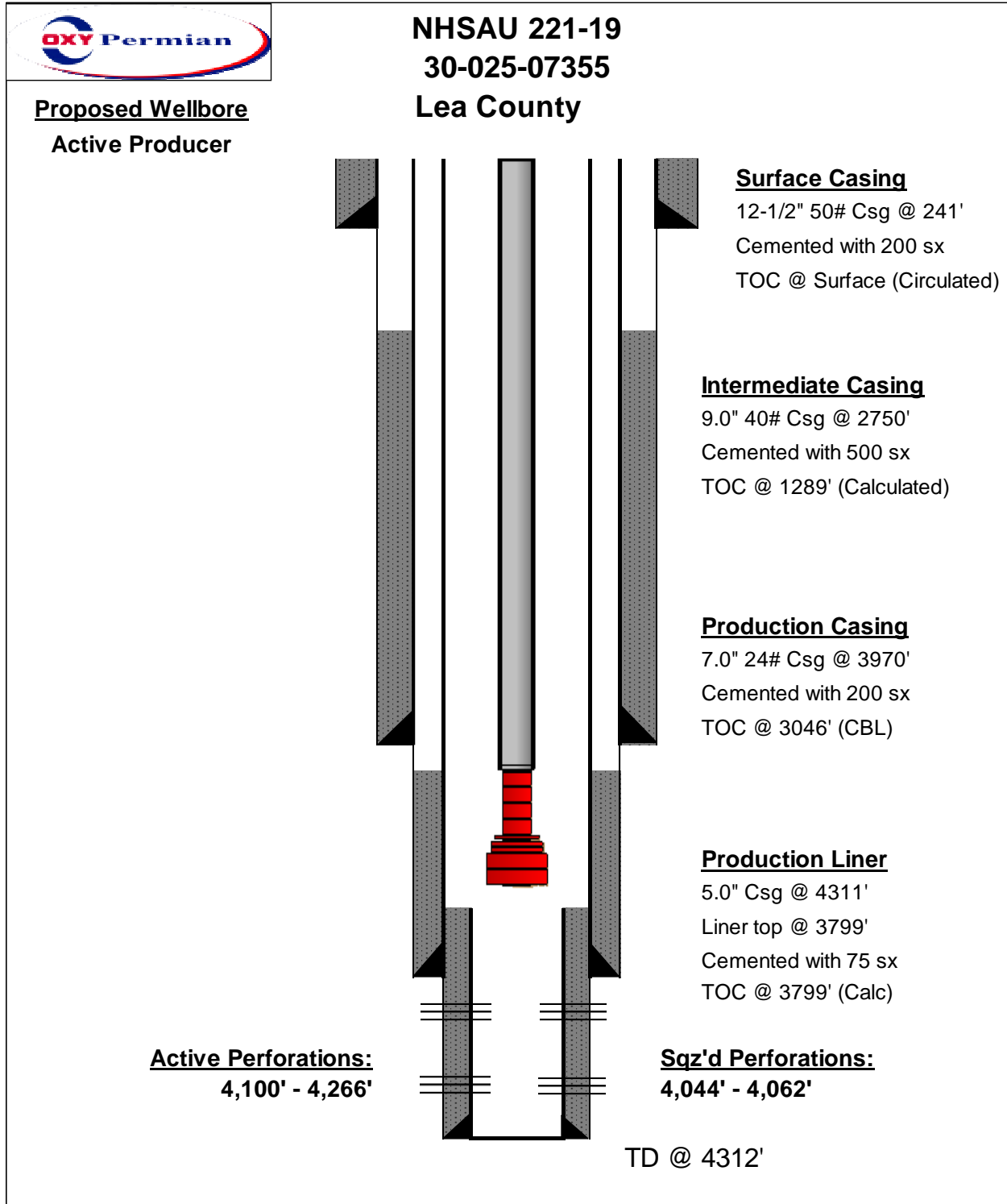

10. Run production equipment. Land ESP @ ~3785'.
11. RD PU
12. Return well to production
