Solaris would like to give notice of intent for a remedial workover on the above captioned well to test mechanical integrity of the 7", 29#, P-110, LTC parent casing beginning on or around 08/08/2023. The plan is to rig up a pulling unit with hydraulic BOPs and pull the existing injection tubing string leaving the permanent packer in the hole. Two retrievable bridge plugs will be ran on wireline and set approximately 10' and 20' above the existing permanent packer. A mechanical integrity test will be called out and performed.

If the test passes it is our intent to request a T&A status for this wellbore. A current and proposed wellbore diagram are attached for reference.

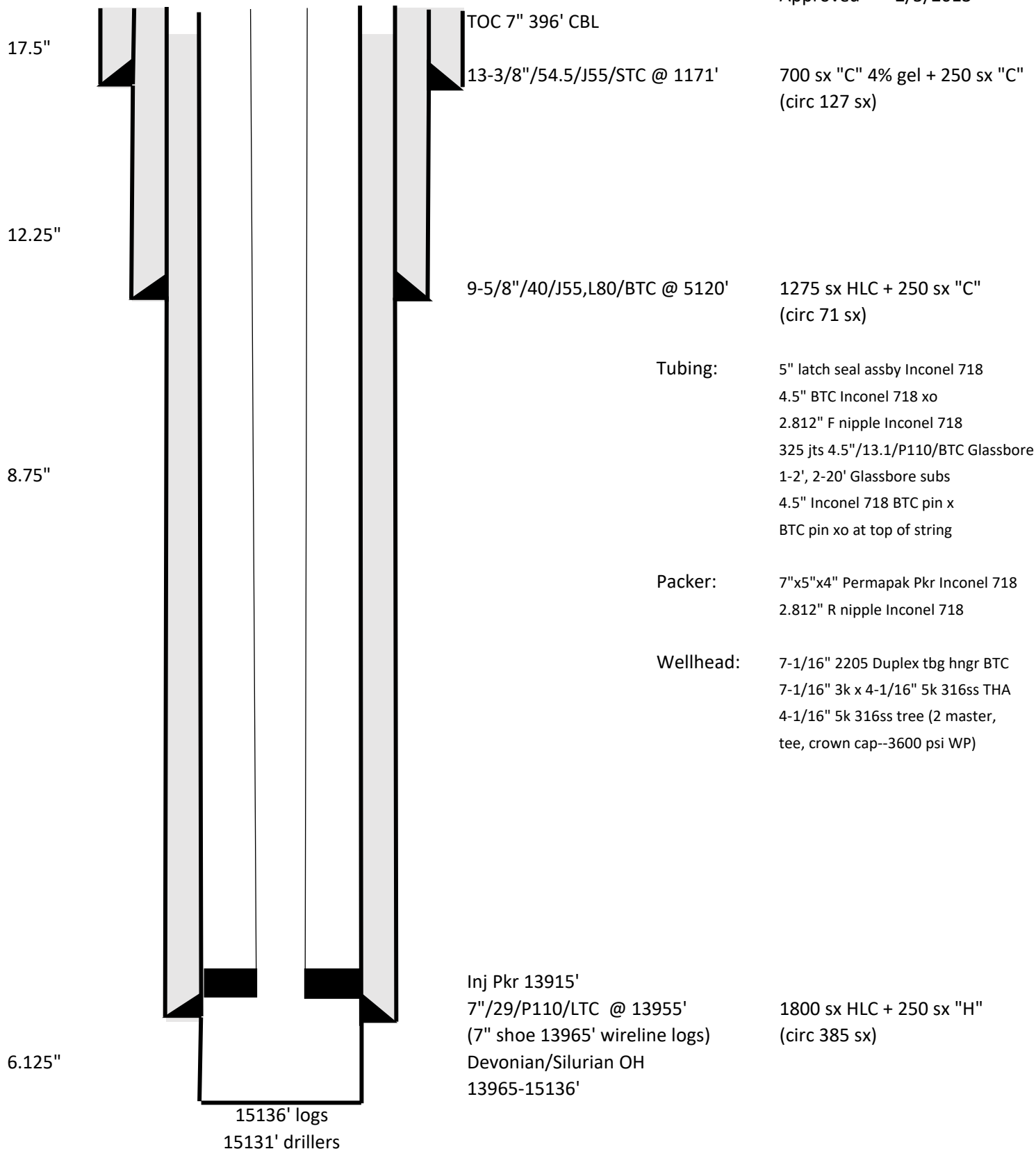

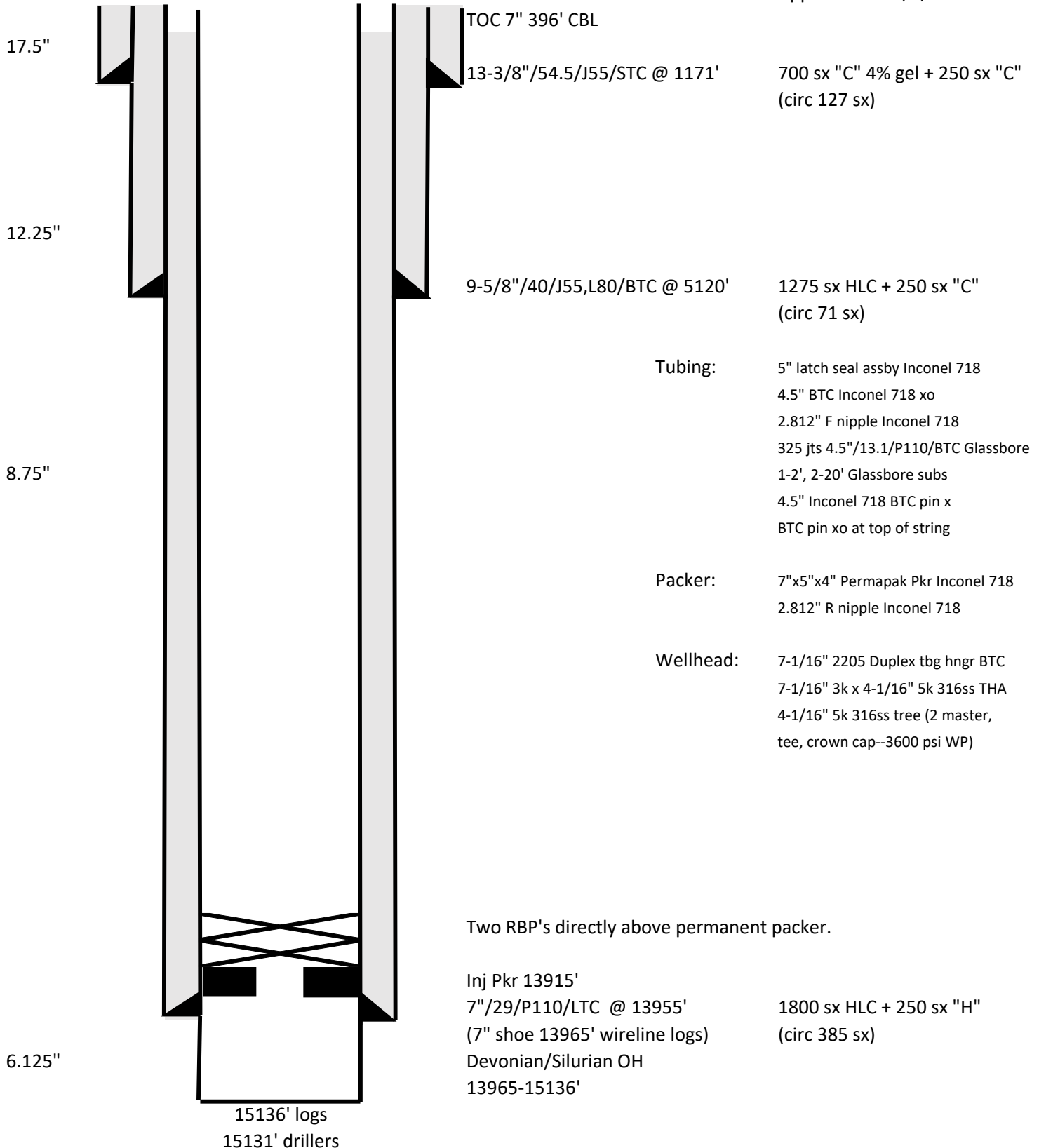
