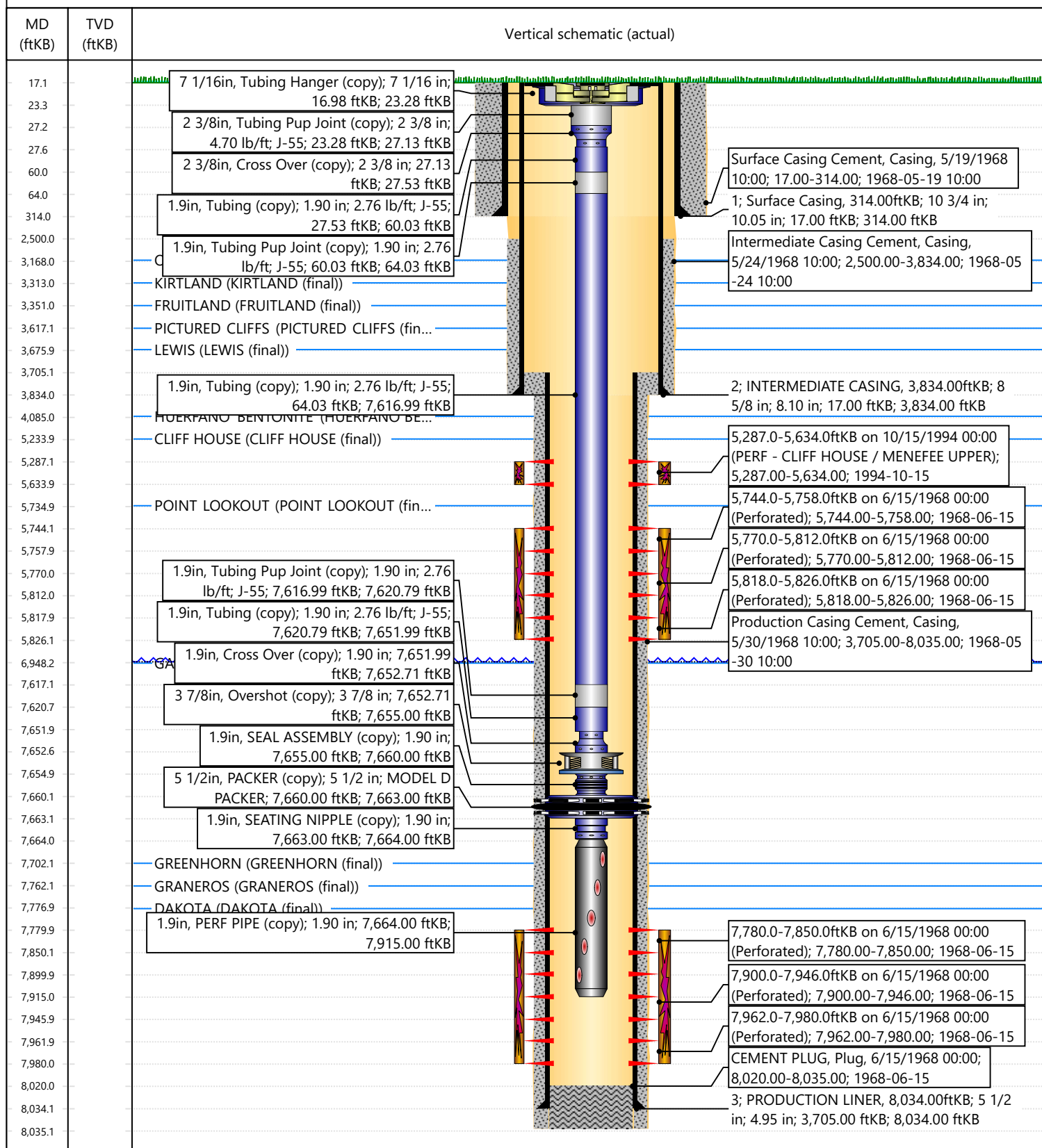


Current Schematic - Version 3
