Pliny the Elder Fee 232H Intermediate and Production Casing

9/17/2022: Test BOPS. Drill 9.875 intermediate hole to 9128 ft.

9/21/2022: Run 7.625 inch 29.7 lb P-110 intermediate casing to 9071 ft. Pump 25 bbls fresh water, followed by 725 sks of 10.5 ppg lead cmt, 240 sks of 13.2 ppg tail cmt. Drop plug and displace with 414 bbls fresh water. 160 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 2000 for 30 minutes, good test.

9/21/2022: Drill 6.75 inch production hole to 19830 ft.

10/2/2022: Run 5.5 inch 20 lb P-110 production casing to 19811 ft MD. Pump 40 bbls fresh water spacer, then 1205 sks of 14.5 ppg tail cmt. Drop plug and displace with 20 bbls sugar water, 390 bbls brine and 28 bbls fresh water. 0 bbls returned to surface. Est TOC at 5600 ft.
