10/16/2022: Test BOPS. Drill 12.25 intermediate hole to 5260 ft.

10/17/2022: Run 9.625 inch 40 lb J-55 intermediate casing to 5245 ft. Pump 20 bbls fresh water, followed by 825 sks of 11.0 ppg lead cmt, 320 sks of 14.8 ppg tail cmt. Drop plug and displace with 394 bbls fresh water. 80 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test.

10/18/2022: Drill 8.75 inch production hole to 10353 ft then switch to 6.75 in hole to 15972 ft.

10/15/2022: Run 5.5 inch 20 lb P-110 production casing to 15952 ft MD. Pump 20 bbls gel spacer, then 460 sks of 10.5 lead cmt, 725 sks of 13.2 ppg tail cmt. Drop plug and displace with 20 bbls sugar water and 333 bbls fresh water. 0 bbls returned to surface. Est TOC at 2206 ft.
