Acidize OH from 3810'-4065' w/ 3000 gals 15% NEFE HCL acid, 1000# rocksalt & flush w/ 30 bbls 2% KCL water. Acidize old perfs from 3676-3655' w/ 2500 gals 15% NEFE HCL acid, 750# rocksalt & flush w/ 30 bbls 2% KCL water. POOH w/ RBP & pkr. TIH w/ production string. RIH w/ pump & rods. RDMO. RTP.


