



Mr. Forrest J. Mayer:

KGCK LLC, owner of the Quintin City Ranch, requests that EOG Resources, 104 S. Fourth Street, Artesia, NM be relinquished of the Emjay BBJ Federal #1 well pad (approximately 1.45 acres) and access road (approximately 3.20 miles in length), shown on enclosed plat, (highlighted in yellow) of the Emjay BBJ Federal #1, Section 8, T6S-R30E, Chaves County, New Mexico. This well pad and road is to be utilized solely for ranch operations. By use of the road, ranch personnel can avoid surface disturbance which would otherwise be required for access, and the pad can be used for a salt lick site. KGCK LLC also requests that EOG Resources, Inc. be relinquished of any future liabilities associated with the well pad and access road as well as any future maintenance, repairs and or upkeep of the well pad and access road. With the relinquishment, EOG Resources, Inc. will not conduct normal reclamation actions required by the Bureau of Land Management/Roswell Field Office for this location and road.


