Note: WOR on location currently. Tubing is out of hole.

Procedure:

1. RU WLU and associated equipment. PU 7" 10k CIBP and RIH. Tag liner top. Pick up +/- 5ft. Set CIBP. POOH
2. MU cement dump bailer, RIH and dump bail 35ft cement cap on top of CIBP, making PBTD +/- 2,185'. POOH. Allow for cement to set.
3. PU 7" packer and 2-3/8" workstring. Set packer below bottom Fruitland Coal perforation +/- 2,100'. MIT the CIBP and cement through the workstring to 500psi. Chart and record test.
4. Release 7" packer, pick up and set packer above top fruitland coal perforation +/- 1,950'. MIT the casing to 500psi. Chart and record test.
5. POOH with packer and workstring. Run back in hole with production assembly, ND BOPs, NUWH. Check for leaks at surface. RDMO WOR and RTP.




