3. RIH w/ 4-3/4" bit and clean to TD @ 3,995'
4. POOH w/ bit
5. RIH w/ sonic hammer and acidize open hole with 7,000 gallons of 15% HCL
6. Lay down rental equipment
7. Pick up injection packer and tbg
8. Set packer @ 3,860'
9. Notification to OCD 24hrs prior to MIT
10. Commence water injection as per the injection permit allowable pressure and rate

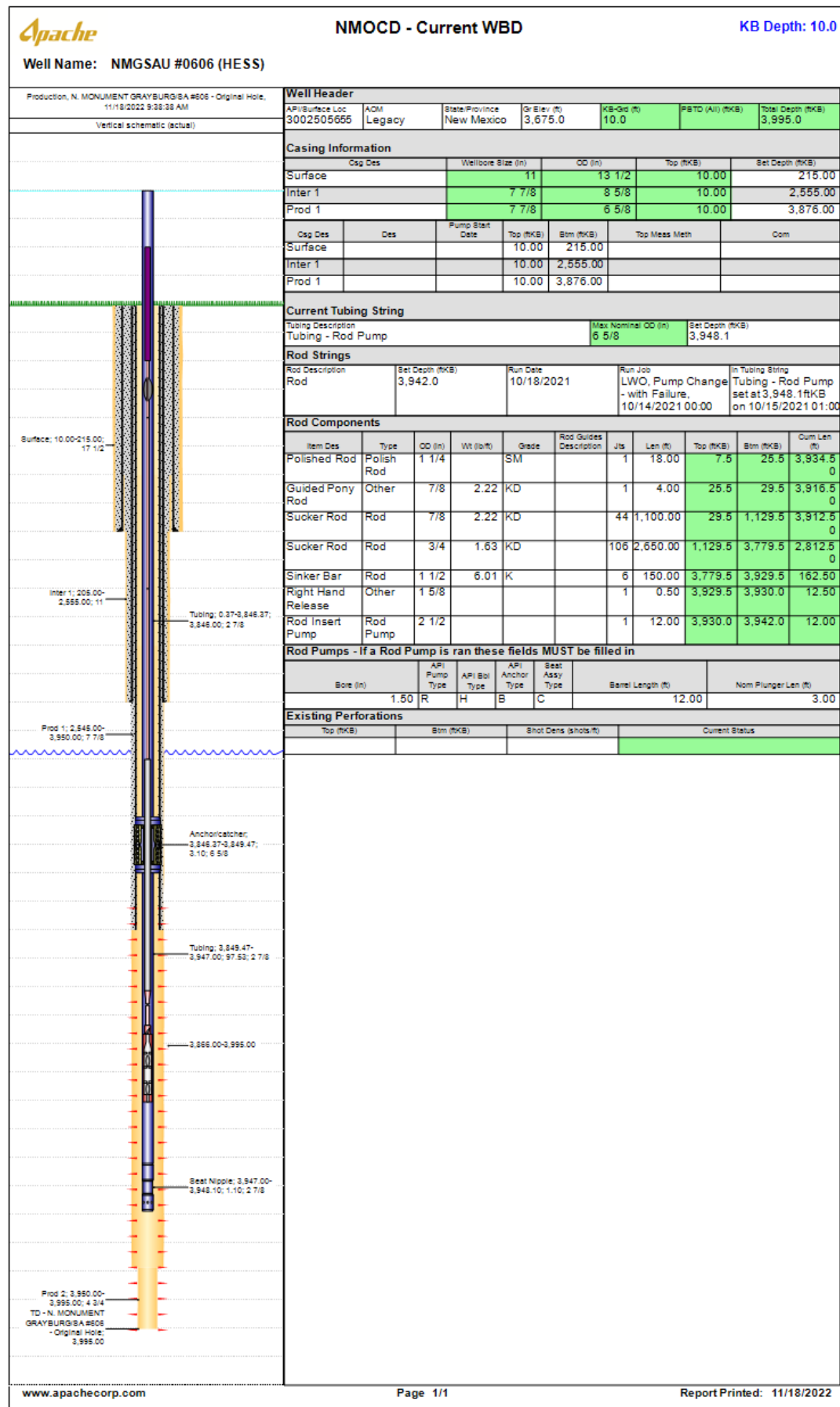
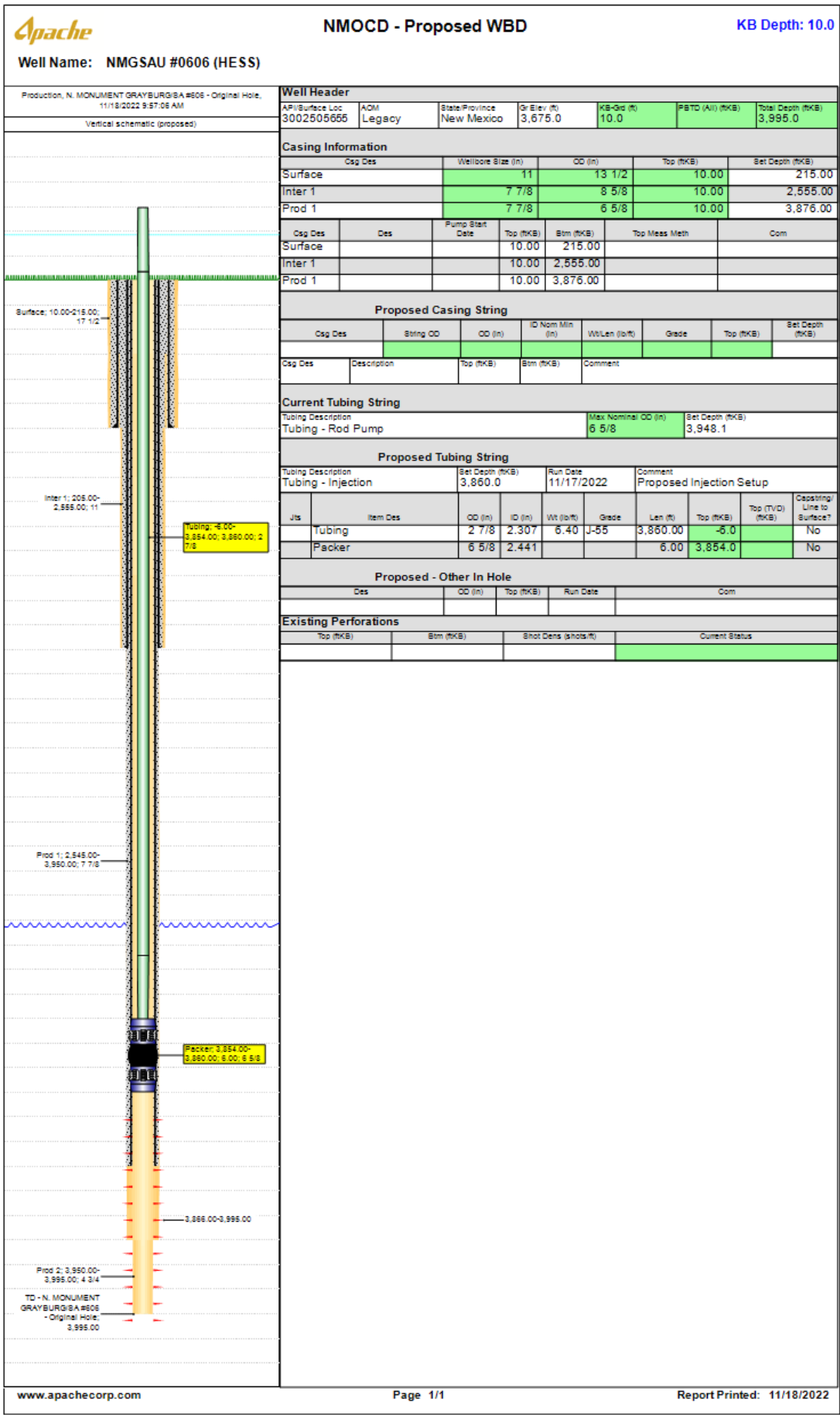
Figure 1 – Current Wellbore Diagram
