

Good morning Keith,

Per our phone call today, when we proceed to plug and abandon the Big Eddy Unit 087, we will modify steps 11 and 12 of the procedure on the 2022.09.08 COA such that we will perforate at 2984' and squeeze 40 SKS Class C cement from

2984' to 2834', thereby isolating the 8-5/8" casing shoe. We will thereafter perforate and squeeze cement across the top of the Delaware formation group, per step 10 of the same procedure.
