10/12/23: NU BOP. PT BOP. Pies and blinds tested to 3000 psi on the high and 300 on the low. PT good and charted. TOH std back and tally 80 jnts 2-7/8 L80 tbg.

10/13/23: TOH std back and tally 92 jnts 2-7/8 tbg. TOH LD and tally 3 jnts (1

was the perfed int. Total out of hole 175) to the parted rods. RU rod table and TOH

LD rods (84 each 3/4" rods, 10 each 1 1/4" K bars, 1 each 3/4" guided sub and rod


