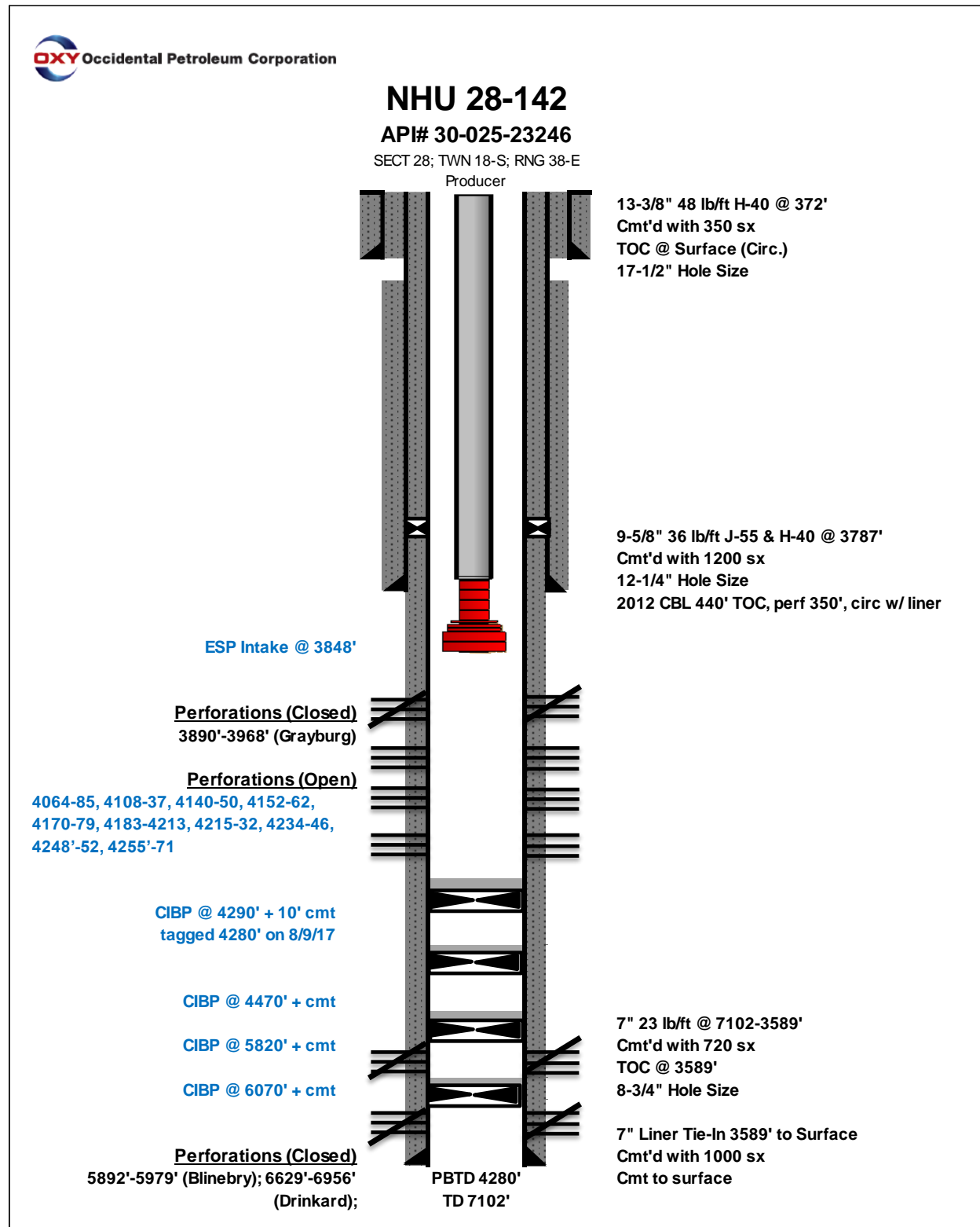

Proposed WBD

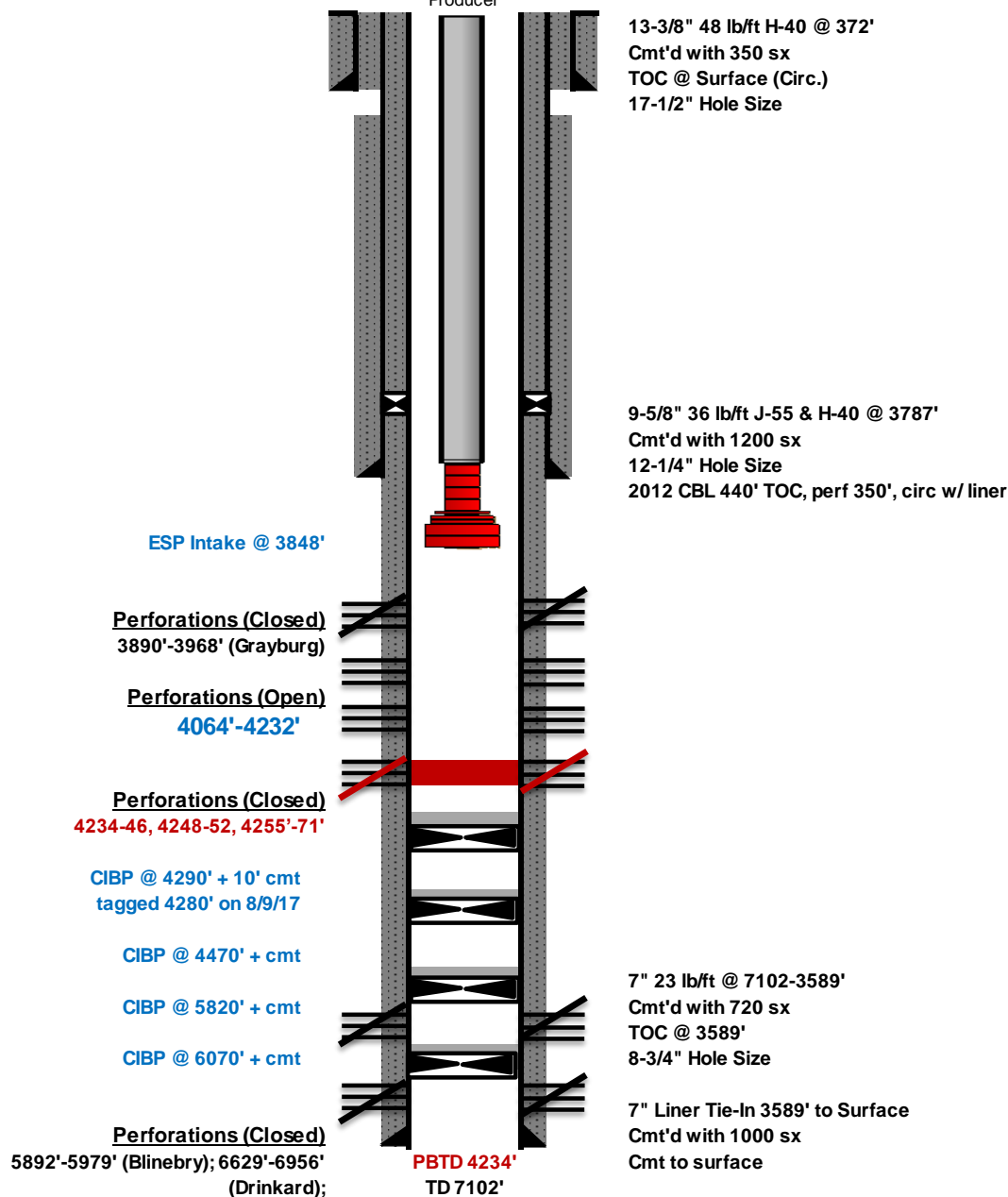
