Pump 50 bbl spacer, followed by 485 sks of 14.8 ppg tail cmt. Drop plug and displace with 53 bbls freshwater. 61 bbls of cement returned back to surface with top job. EST TOC at 0 ft. Pressure test casing to 1500 PSI for 30 minutes, good test. 4/14/2023: Test BOPS. Drill 9.875 intermediate hole to 8571 ft. 4/17/2023: Run 7.625 inch 29.7 lb P-110 intermediate casing to 8523 ft. Pump 20 bbls fresh water, followed by 1025 sks of 11.5 ppg lead cmt, 350 sks of 13.2 ppg tail cmt. Drop plug and displace with 20 bbls of fresh water then 369 bbls of OBM. 148 bbls cement to surface.
