3/15/23 - OCD rep on site - RIH w/overshot and caught tubing - jarred 3 times and came free - POOH w/3 feet of tubing to 1780'. RIH and caught tubing. Jarred 5 hours - no movement. POOH and lay down overshot and jars. Set packer at 1500' squeeze 40SX class C and S/I WOC.

3/16/23 - Tag TOC @ 1597' per @ 1547 wouldn't squeeze - Spot 25 SX Class C - WOC - tag @ 1076' Perf @ 431 - wouldn't squeeze - RIH to 482' spot 60 SX Class C to surface.

3/17/23 - Rig down.

3/20/23 - Move all equipment off location.

3/27/23 - Remove wellhead and install sub-surface dry hole marker.

10/23 - Durango removed piping and equipment.

Surface reclaimed and ready for release.
