The facilities described in PLC 749F are unchanged – each facility has a sales-quality orifice meter (BLM gas FMP or equivalent meter) that continuously measures gas volume before it leaves the facility. Production upstream of the facility gas FMP or equivalent meter is allocated to each well based on well test.

This request is for gas production only. Oil production will be handled through an amendment to PLC 609B for Pure Gold CTB Train #1 (K-29-23S-31E).

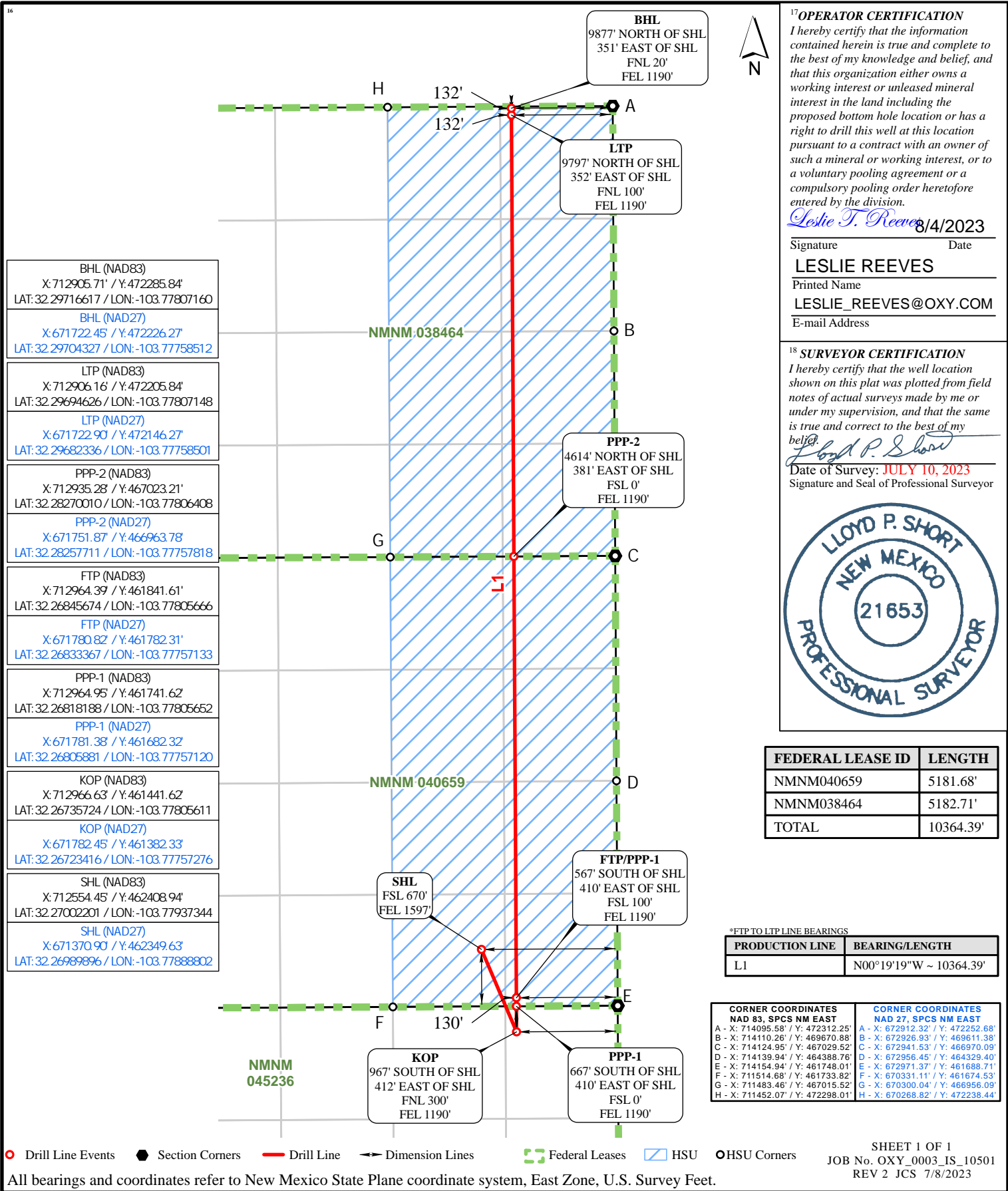
