

### **Procedure:**

1. MIRU P&A rig.
2. MIRU WLU and ran CBL from 3594' to surface. Found good cement from 3594' – 2250' and 200' – surface.
3. Circulated mud laden fluid.
4. Spot 25 sks of Class C cement @ 3590' (top of CIBP). WOC & tagged @ 3340'.
5. Spot 50 sks class C cmt @ 2686' (Yates & B/Salt). WOC & tagged @ 2233'.
6. Perf & sqz'd 50 sks class C cmt @ 1364' (T/Salt & 7-5/8" shoe). WOC & tagged @ 1085'.
7. Perf'd @ 281' and pressured up to 1000 psi for 15 minutes. Instructed by the NMOCD to spot 50 sks of Class C cement @ 331'. WOC & tagged @ surface.
8. RDMO P&A rig.
9. Notified NMOCD.
10. Dug out around wellhead and cut. Welded DHM and cleaned location.
