Actual Procedure: Well spud on 5/26/2023 at 17:00 5/26/2023: Drill 17.5 inch surface hole to 405 ft. 5/26/2023: Run 13.375 inch 54.5 lb J-55 surface casing to 390 ft. Pump 20 bbl water spacer, followed by 500 sks of 14.8 ppg tail cmt. Drop plug and displace with 53 bbls freshwater. 5 bbls of cement returned back to surface. EST TOC at 0 ft. Pressure test casing to 1500 PSI for 30 minutes, good test. 5/29/2023: Test BOPS. Drill 12.25 intermediate hole to 2831 ft. 5/30/2023: Run 9.625 inch 40 lb J-55 intermediate casing to 2817 ft. Pump 20 bbls water spacer, followed by 860 sks of 13.2 ppg lead cmt 210 sks of 14.8 ppg tail cmt. Drop plug and displace with 210 bbls of brine. 106 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test. 6/9/2023: Drill 8.75 inch production hole to 6583 ft then switch to 7.785 inch hole to 14516. 6/15/2023: Run 5.5 inch 20 lb P-110 production casing to 14496 ft MD. Pump 40 bbls water spacer, then 420 sks of 11.0 ppg lead cmt and 1405 sks of 13.2 tail cmt. Drop plug and displace with 20 bbls sugar water and 300 bbls fresh water. 0 bbls cement returned to surface. Est TOC at 2200 ft.
