**Plugging Report**  
**East Hobbs San Andres Unit #914**  
**30-025-07964**

6/10/2024 Cleared location and set matting board. Rigged up. Pump is stuck. Made back off attempt. Shallow back off. Started laying down rods. Shut down for storm.

6/11/2024 Laid down 44 7/8" and 53 3/4" rods. Installed BOP. Dug out cellar to change the surface connections. Surface head has cement in it. Installed the BOP and worked the anchor free. POOH with tubing to rods. Continued to strip the rods and tubing for the remainder of day. 52 stands and a single and 135 rods recovered.

6/12/2024 Finished stripping rods and tubing. 131 joints 2 7/8" tubing and 166 total rods. Made gauge ring run and set cement retainer at 4175'. Squeezed under the retainer with 50 sacks Class C. Left 15 sacks cement in the tubing after displacing, stung out of the retainer and dumped cement on top of the retainer. POOH and SION.

6/13/2024 Set 5.5" CIBP at 3900'. RIH with tubing and tagged CIBP. Circulated MLF and tested casing to 550#. Good. Spot 25 sx cement on top of CIBP. POOH and top of casing with brine. Rigged up The Wireline Group and ran RBL. TOC at 3340'. Free pipe from 3340' to 604'. Cement from 604' to surface. Rig down wireline and SION.

6/17/2024 Perforated casing at 3125'. Set packer and established rate. Squeeze perms with 50 sx Class C cement. WOC and tagged cement at 2889'. POOH and perforated at 1951'. Set packer, established rate and squeezed with 50 sx cement. Left packer set and SION.

6/18/2024 Released packer and tagged cement at 1783'. POOH and lay down packer. RIH with tubing to 654' and circulated cement to surface with 65 sx cement. Lay down tubing and rig down. Dug out and removed the wellhead. Good cement in the 7 5/8" x 5 1/2". Filled up 5 1/2" with 2 sx cement. Installed standard marker, removed the anchors, cleaned the pit, cleared the location and moved out.


