RU to cement. 3500 psi test on lines, test good. LEAD: Type III/Poz, 229 bbbs (600sx) 12.5 ppg, 2.15 yield, 12.00 gps (surface 4158). TAIL: Type III/Poz, 46 bbbs (151sx), 13.5 ppg, 1.71 yield, 8.88 gps (4158 5925). Bump plug at 3068 psi, hold for 5min. Floats held. Circulate. 70 bbbs cement to surface.
