An OCD approved Subsequent Report notes the well was returned to injection on 1/16/2019 and Oxy records nor OCD records show a TA job since this RTI was performed. Injection volumes have been reported in January 2024. A BHT Report dated 3/7/2024 noting the well as active and not TA'd was OCD approved on 5/14/2024.

Occidental Permian LTD is requesting the OCD well status be updated to reflect the subject well as Active Injector.
