Dugan Production P&A'd the well on 08/07/24-08/08/24 per the following procedure:

- MI&RU Aztec Rig 481 and cement equipment. Check pressures, Tubing 0 psi, Casing 33 psi, BH 0 psi.
- Run 5½" casing scraper to 1163'.
- RIH & set 5½" cement retainer at 1130'. Fruitland Coal perforations @ 1176'-1195'.
- Load and circulate hole. Run CBL from 1130' to surface. Sent copy of CBL to NMOCD/BLM.
- Sting in the retainer. Attempt to pump below the CR through the perforations. Cannot pump through. Pressured up to 1000 psi. Sting out. Notified NMOCD/BLM. Spot inside Plug I above CR @ 1130' w/58 sks (66.7 cu ft) Class G neat cement to cover the Fruitland top (5 gal/sk, 15.8 #/gal, 1.15 cu ft/sk). Displaced w/2.4 bbls water. WOC overnight. Tagged TOC at 634'. Good tag. **Plug I, inside 5½" casing, 634'-1130', Fruitland, 58 sks, 66.7 cu ft.**
- Attempt to pressure test casing to 650 psi. Casing tested good for 30 minutes.
- Check pressures, Casing 0 psi, Tubing 0 psi, BH 0 psi.
- Spot inside Plug II from 439' w/70 sks Class G neat cement (80.5 cu ft) to cover the Kirtland-Ojo Alamo and surface casing shoe to surface. Brought back 1 bbl cement to surface. Cut wellhead off. Tagged TOC at 0' inside the 5½" casing and 30' inside the annulus. Good tag. **Plug II, inside 5½" casing, 0-439', Kirtland-Ojo Alamo-Surface, 70 sks, 80.5 cu ft.**
- Install dry hole marker and filled up casing with 22 sks, 25.3 cu ft Class G neat cement.
- Clean location. Rig down Aztec 481 and move. Clay Yazzie w/BLM witnessed job.
- **Well P&A'd 08/08/24.**

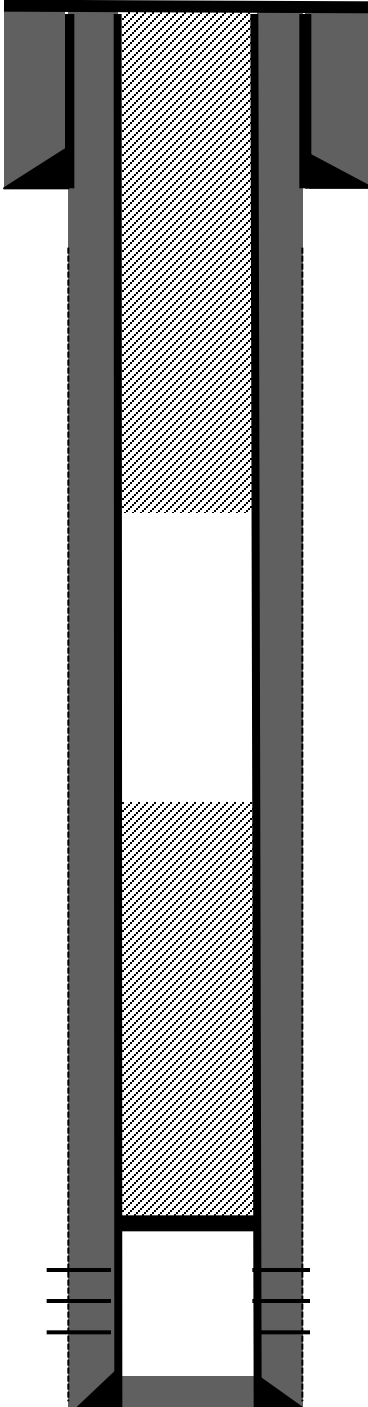
