Packer tests can be performed while other wells are being drilled. I understand the inability to perform test during completion but not the drilling.

Logos tends to extend the test time on packer tests instead of trying to do it earlier and getting as close to the year as they can. Logos needs to come up with a better scheduling plan for their packer tests. I believe this has been stated before. Part of NMOCDs reason for being is to protect correlative rights.
