11/9/2023 - Run 13-3/8", 54.5#, J55, BTC surface casing to 1001'. Cement casing with 1431 sacks, 1.33 yield, Class C, of LEAD cement with 210 bbls of cement circulated to surface. Pressure test casing to 1500 psi for 30 min, held, good test. Skid Rig off.

11/25/2023 - Skid rig back on. Notify BLM on intent to test BOP. Test BOP. Drill out cement, float shoe and 10' of new formation to 1020'.

11/26/2023 - 12/3/2023 - Drill 12-1/4" intermediate hole to 11621'. Notify BLM of intent to run casing and cement.

12/4/2023 - Run 9-5/8", 40#, P110, BTC, intermediate casing to 11601'.

12/5/2023 - Cement casing with 1431 sacks, 3.91 yield, Class C, lead cement and 1441 sacks, 1.14 yield, Class C, tail cement with 22 bbsl of cement circulated to surface. Pressure test casing to 4000 psi for 30 min, held, good test. Drill out float equipment, cement and 10' of new formation to 11631'.

12/6/2023 - 12/15/2023- Drill 8.5" production hole to 16827'.
