Tested tubing with pump truck and tubing leaked. Rigged back up on well. Pulled rods, downhole pump, and tubing. Tested tubing back in hole and replaced damaged joints. Set TAC and EOT at same depth as previous. Re-ran rods and downhole pump. Set all equipment back at same depth.
