

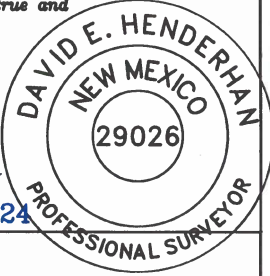

ACREAGE DEDICATION PLATS

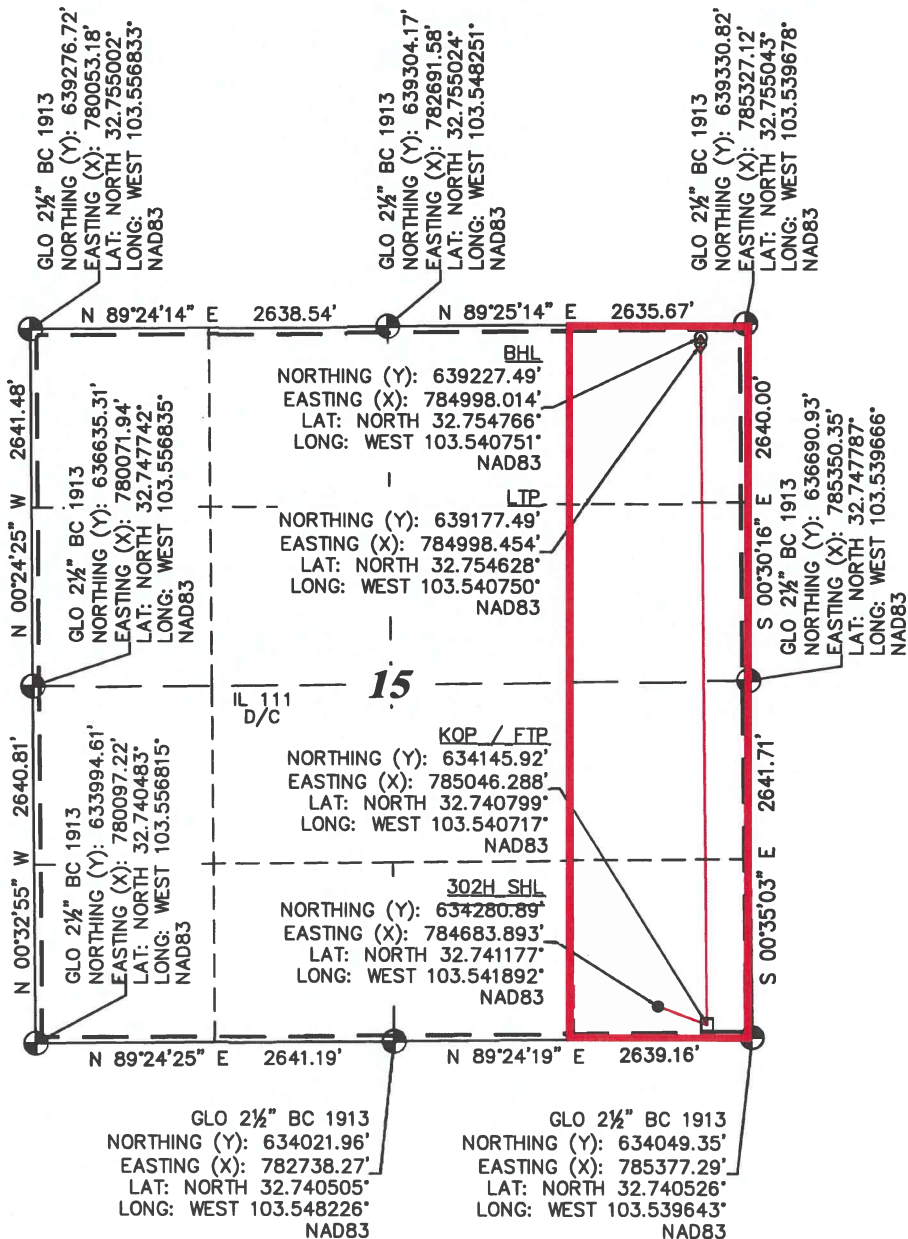
