Procedure Description: Longfellow Energy respectfully requests a 2-year extension for the following reasons: 1) Well pad has not been built; 2) More time is needed to evaluate the results from proximate active drilling activities and recently completed wells; 3) Longfellow intends to change the Ozzy 18D 1H, 2H, 3H wells from 1-mile laterals to 2-mile laterals. This change would improve drilling efficiency and eliminate the need to drill four other approved wells - Ozzy 18D 4H and Angus 17 1H, 2H, 3H.
