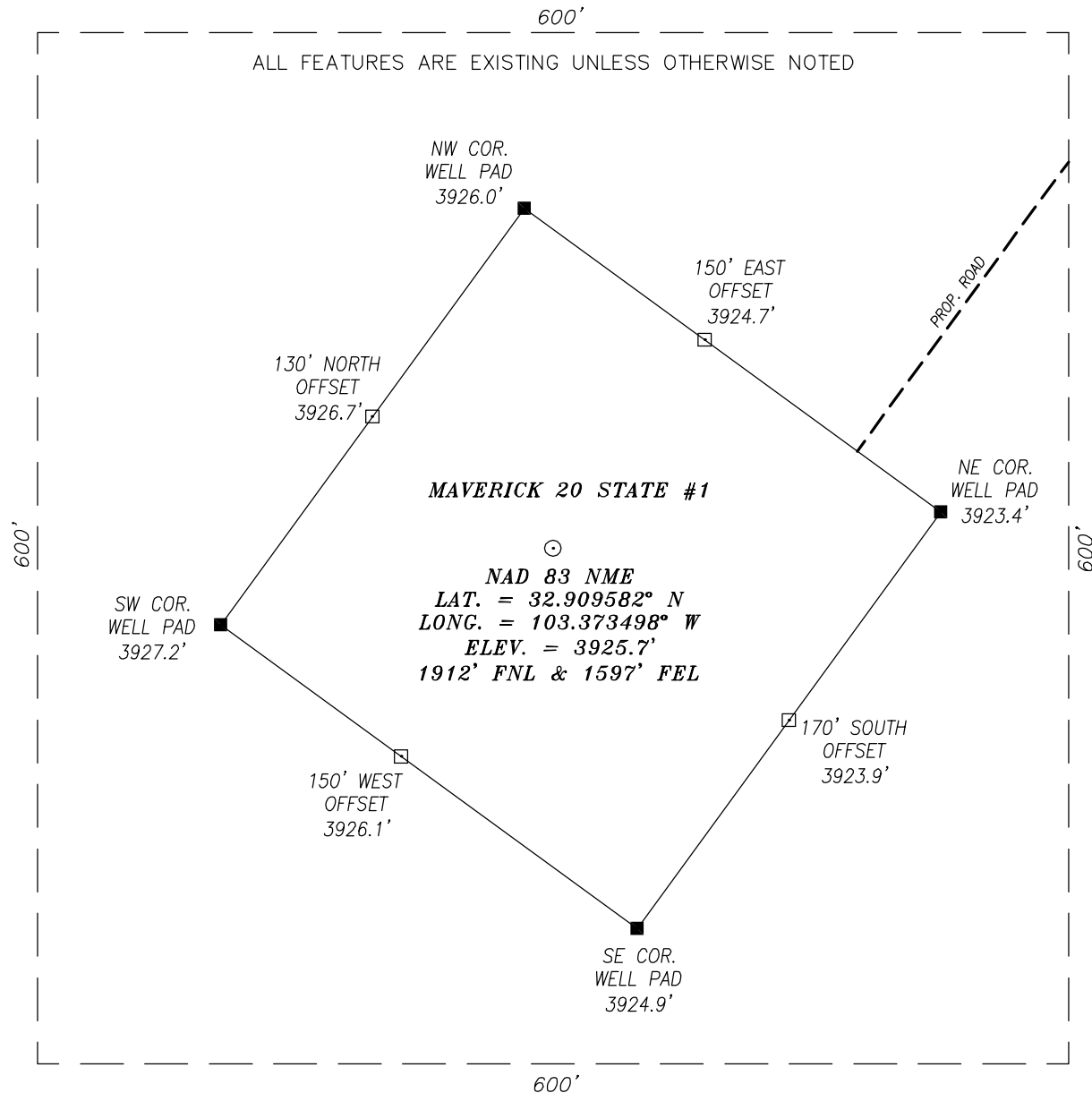

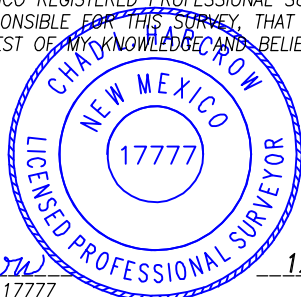


DIRECTIONS TO LOCATION

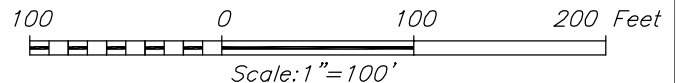

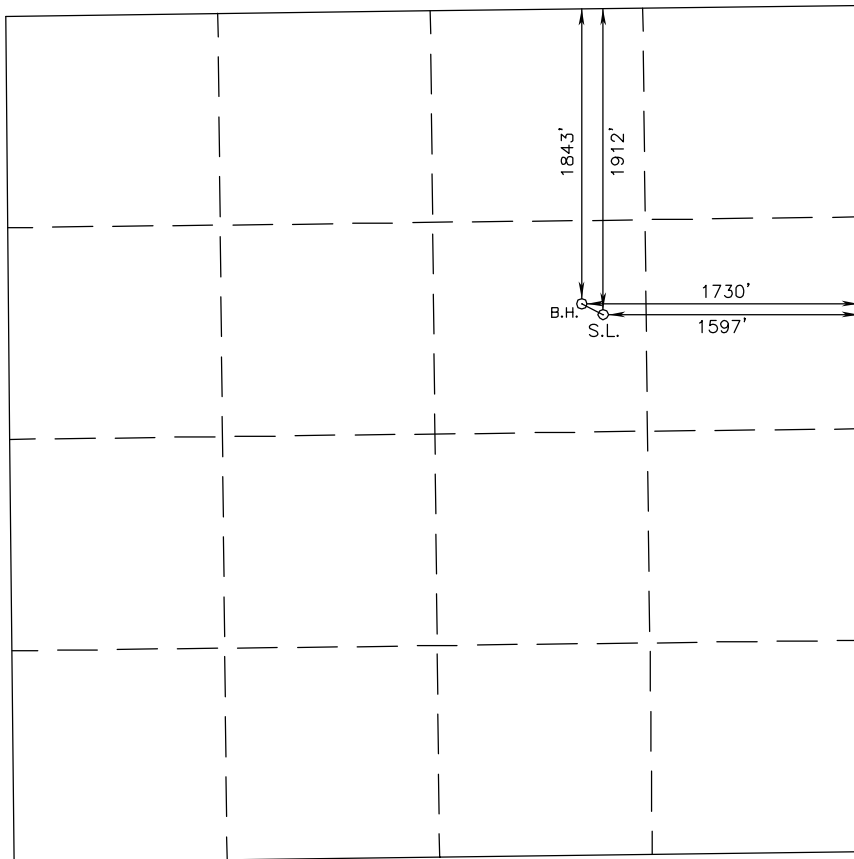
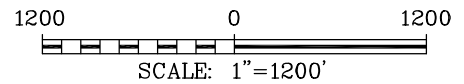
