Actual Procedure: Well plugged by the Navajo Nation, contractor Walsh Engineering and Production. Work completed July 31, 2025. Daily Events 7/29 SICP=0PSI. MIRU. Moved in equipment. ND Tbg head and NU BOP. Function test BOP. MU bit and scraper for 4-1/2" casing and tih. Tally and rabbit tbg on the way in. Ran bit and scarper to 1074' with 33 joints in. LD single and stand back 16 stands (32 jts). LD bit and scraper. TIH with CICR on 2-3/8" Tbg. Set CICR at 1051' with 32 its plus 10' of subs. Stung out of retainer and rolled the hole with fresh water pkr fluid. Circulated appx 10 bbls of oil back to wash pit. Pumped a total of 23 bbls of pkr fluid. Attempted pressure test to 800 psi. lost 80 psi in 10 minutes. Isolated pump and tested again with the same results. POH with setting tool. RU TWG to run CBL. Ran CBL. Showing good cement for the most part except around 50', showing free pipe for about 10 ft. RD WL. TIH with openended tbg to 1050'. Secured the well for the evening. Crew off location at 18:00. Johnny Begaye NNMinerals Inspector on location to witness operation. 7/30 SICP=0PSI. Function test BOP. EOT @1051'. M&P 24 sks, 27.6cuft, 15.8#, 1.15 yield, 4.9 bbls, Class G Neat cement from 1051' to 749'. POH with 16 jts. WOC. TIH and tagged cmt at 853'. 243' above Gallup top at 1096'. POH with tbg. RU TWG. TIH with perf guns. Shot 4 holes at 150'. POH with guns. Verfified all shots fired. Closed blind rams and attempt to est injection rate and circulation out of cellar. Pressured to 620 psi. No injection rate. Slow leak off. Discussed results with NNMinerals Inspector and BLM Engineer. Will shoot 4 holes at 50'. RU WL and rih to 50'. Shot 4 holes at 50'. POH with guns, verified all shots fired. Closed blind rams and attempt injection rate and circulation out of cellar. 2bpm/0psi 3bpm/0psi 4bpm at 20psi. Pumped 3 bbls no circulation. TIH with 5 jts of tbg. EOT at 160'. M&P 70 sks, 1.15 yield, 15.8#, 80.5 cuft, 14.3 bbls. Pump cement till getting returns to wash pit, then closed csg valve and pump cement. All cement pumped. 240 psi showing. Bled pressure back to wash pit slowly. Got back .5 bbls and guit. POH laying down tbg. Flushed out tbg with water. ND work floor and BOP. NU Blanking plate and cap to secure the well. WOC.


