LOGOS Operating LLC proposes to remediate annular gas migration identified during the recent bradenhead test on the Julander Federal #1E well.

Remediation will be performed using the Punch & Inject (P&I) Tool. The tool will mechanically perforate the casing and inject resin directly into the micro-annulus to restore pressure integrity. Following resin placement, the well will be pressure tested to confirm the effectiveness of the repair.

Planned injection intervals and volumes:

1404 2 gallons (LET floor/ceiling confinement)

990 2 gallons (LET floor confinement)

675 2 gallons (natural cement confinement)

The work will be completed in a single trip/day operation, and a metal-to-metal seal will be maintained during the resin cure phase.
