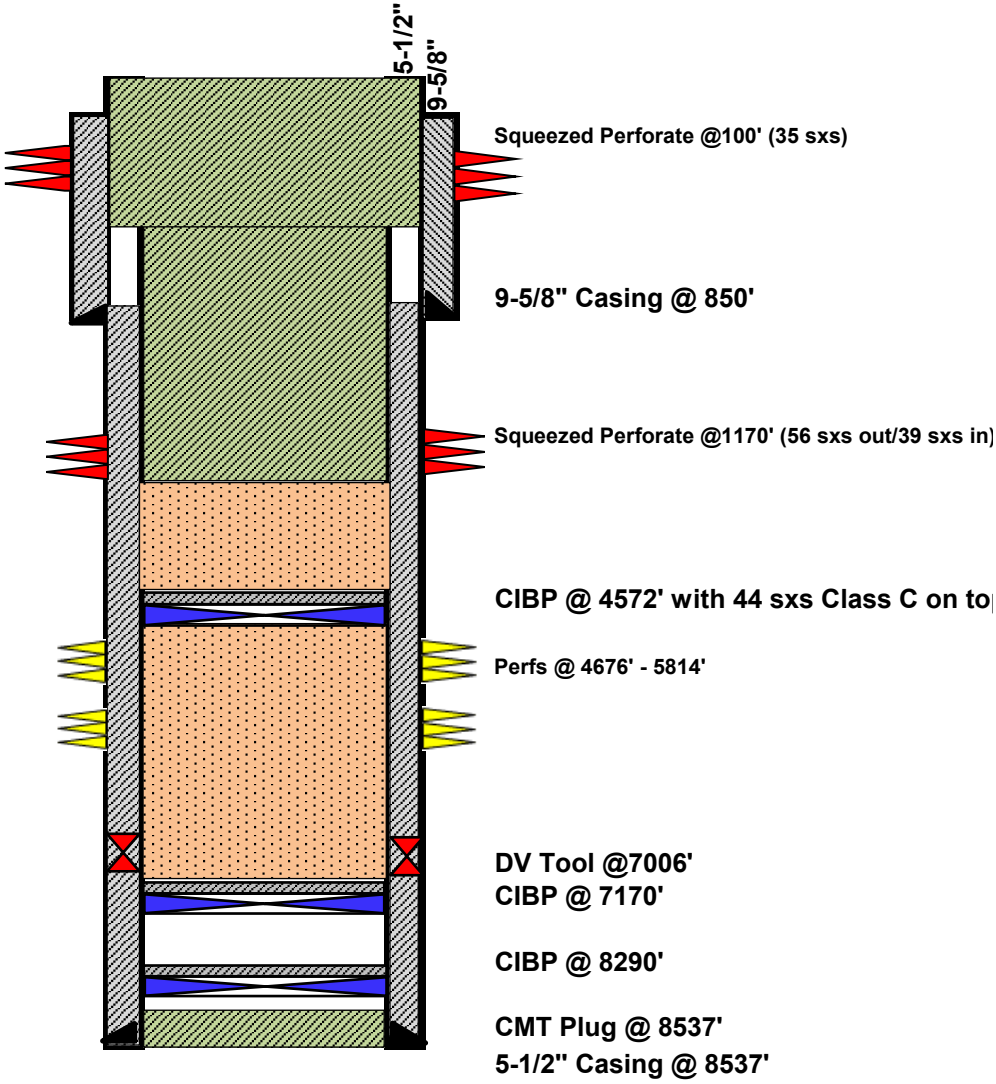

MIRU WSU. 7/1/25: Pump kill mud to kill well. ND Wellhead NU BOP. Release Packer. TOOH with injection tubing. 7/2/25: MIRU WL and run CBL. RDMO WL. 7/3/25: Set CIBP at 4572'. Spot 44 sacks of class c cement on top of CIBP. POOH w/ work string. Pressure tested. Good test. WOC. 7/4/25: Tag TOC @4138'. MIRU WL. RIH at 1170'. Squeeze 56 sacks of class c cement outside casing 2 bpm @ 600 psi. Spot 39 sacks of class c cement. WOC. 7/5/25: Tag cement @ 256'. Pressure test braden head to 300 psi. Good test. MIRU WL. Perforate at 100'. RDMO WL. Established injection rate. Cement from 100' to surface with 35 sacks of class c cement at 3 bpm at 200 psi. Cut off wellhead. Install P&A marker to comply with regulations. Record GPS coordinate for P&A marker on tower report. Photograph P&A marker in place. RDMO.
